On September 24, 2024, the Company completed a non-brokered private placement (the "Offering") of 40,000,000 units in the capital of the Company (the "Units"). Each Unit was comprised of one common share in the capital of the Company (each, a "Common Share") and one Common Share purchase warrant (each, a "Warrant"). Each Warrant entitles the holder thereof to acquire one Common Share at a price of \$0.05 per Common Share for a period of eighteen (18) months from the date of issuance.

As a result of the Offering, Scryb's ownership of the Company decreased to approximately 6.78% on an undiluted basis and 7.55% on a partially diluted basis, resulting in Scryb's ownership position to decrease below 10%.
