Immediately prior to the Purchase, Mr. Johannson was the legal and beneficial owner of 9,459,000 Common Shares of the Issuer, representing approximately 17.43% of then issued and outstanding Common Shares.

Immediately following the Purchase, Mr. Johannson was the legal and beneficial owner of 14,859,000 Common Shares, representing approximately 26.33% of the issued and outstanding Common Shares (being 56,429,878 common shares).

Mr. Johannson is also the legal and beneficial owner of 250,000 stock options, entitling him to purchase 250,000 additional Common Shares of the Issuer.

Assuming exercise of the 250,000 options, immediately following the Purchase, Mr. Johannson was the legal and beneficial owner of 15,109,000 Common Shares, or approximately 26.77% of the issued and outstanding Common Shares of the Issuer (on a partially diluted basis).
