Developments

In March 2015, it became apparent to management that the company would not be able to develop the Key Fob technology under the established design parameters and prototypes (the agreement entered between the Company and NeuronicWorks Inc. was effective as of January 27, 2014).

FastCorp Management Ltd. ("FCM") previously provided accounting services to the Company and FastCorp Computers Ltd. ("FCC") previously provided electronic filing services for the Company. Effective March 15, 2016, both FCM and FCC were adjudged bankrupt.
