

AREV NANOTEC BRANDS INC. EARLY WARNING REPORT

July 13, 2020 – Mr. Mike Withrow reports that Chiron Capital Inc. ("Chiron"), a company that Mr. Withrow controls, has acquired ownership, control, and direction over 10,779,000 common shares (the "Shares") of AREV Nanotec Brands Inc. (the "Company") representing 60% of the issued and outstanding Shares. The Shares were acquired pursuant to a private placement made in reliance on the private agreement exemption set out in section 4.2 of Multilateral Instrument 62-104 TakeOver Bids and Issuer Bids ("62-104"). As a result of the acquisition of the Shares, Mr. Withrow controls, and Chiron owns, 10,779,000 Shares representing approximately 60% of the issued and outstanding Shares. Chiron has acquired the securities for investment purposes and, as disclosed in the accompanying Early Warning Report, may in the future acquire or dispose of securities of the Company, through the market, privately or otherwise, as circumstances or market conditions warrant. Mr. Withrow and Chiron are accredited investors as defined in NI 45-106.
