Common shares (“**Common Shares**”) and common share purchase warrants (“**Warrants**”) of Randsburg International Gold Inc. (the “**Company**”), head office located at 44 Victoria Street, Suite 1060, Toronto, Ontario, M5C 1Y2. Each Warrant entitles the holder thereof to acquire one Common Share at a price of \$0.0075 per Common Share for a period of two years from the closing date.

A private placement of units (that private placement, the “**Private Placement**”; those units, “**Units**”), each comprised of one Common Share and one Warrant, and a settlement of certain debt by issuing Common Shares (the “**Debt Settlement**”; together with the Private Placement, the “**Transactions**”).

- a. The Acquiror has agreed to acquire from the Company 18,872,017 Common Shares and 5,000,000 Warrants.
- a. The Acquiror’s joint actor, Mr. Mintz (as defined below) has agreed to acquire from the Company 13,320,680 Common Shares and 2,916,667 Warrants.
- b. The Acquiror’s joint actor, Ms. Mintz (as defined below) has agreed to acquire from the Company 13,320,680 Common Shares and 2,916,667 Warrants.

On August 17, 2018, the Company and (i) the Acquiror entered into an agreement to acquire 13,872,017 Common Shares pursuant to the Debt Settlement, along with 5,000,000 Common Shares and 5,000,000 Warrants pursuant to the Private Placement; (ii) the Acquiror’s joint actor, Mr. Mintz, entered into an agreement to acquire 10,404,013 Common Shares pursuant to the Debt Settlement, along with 2,916,667 Common Shares and 2,916,667 Warrants pursuant to the Private Placement; and (iii) the Acquiror’s joint actor, Ms. Mintz, entered into an agreement to acquire 10,404,013 Common Shares pursuant to the Debt Settlement, along with 2,916,667 Common Shares and 2,916,667 Warrants pursuant to the Private Placement.

On completion of the Private Placement and the Debt Settlement, the Acquiror, together with its joint actors, Mr. Mintz and Ms. Mintz, will acquire 45,513,377 Common Shares, which represents approximately 21.64% of the issued and outstanding Common Shares on an undiluted basis, and 10,833,333 Warrants, which together with such acquired Common Shares and assuming full exercise of the Warrants, represents approximately 25.48% of the issued and outstanding shares on a partially diluted basis assuming exercise of Company’s convertible securities and assuming that there is no other share issuance between the date hereof and completion other than an aggregate of 43,333,333 Units pursuant to the Private Placement and 138,720,133 Common Shares pursuant to the Debt Settlement. The Acquiror and its joint actors previously held no securities of the Company.

3.2 State whether the acquiror acquired or disposed ownership of, or acquired or ceased to have control over, the securities that triggered the requirement to file this report.

The Acquiror, together with its joint actors, Mr. Mintz and Ms. Mintz, has entered into agreements to acquire ownership of or control of 45,513,377 Common Shares and 10,833,333 Warrants.

The Acquiror, together with its joint actors, Mr. Mintz and Ms. Mintz, held no securities of the Company prior to the Transactions (0% of the outstanding securities of the Company) and the Acquiror held 45,513,377 Common Shares after the Transactions (21.64% of the issued and outstanding Common Shares of the Company). Assuming full exercise of the Warrants, the Acquiror, together with its joint actors, Mr. Mintz and Ms. Mintz, will hold 56,346,710 Common Shares of the Company (25.48% of the issued and outstanding shares on a partially diluted basis assuming that there is no other share issuance between the date hereof and completion other than an aggregate of 43,333,333 Units pursuant to the Private Placement and 138,720,133 Common Shares pursuant to the Debt Settlement).

On Closing of the Transactions, the Acquiror, together with Mr. Mintz and Ms. Mintz, will have ownership or control over 45,513,377 Common Shares of the Company which represents approximately 21.64% of the issued and outstanding shares on an undiluted basis assuming that there is no other share issuance between the date hereof and completion other than an aggregate of 43,333,333 Units pursuant to the Private Placement and 138,720,133 Common Shares pursuant to the Debt Settlement, and 10,833,333 Warrants, which together with the 45,513,377 Common Shares and assuming full exercise of the Warrants, represent approximately 25.48% of the issued and outstanding shares on a partially diluted basis, assuming that there is no other share issuance between the date hereof other than an aggregate of 43,333,333 Units pursuant to the Private Placement and 138,720,133 Common Shares pursuant to the Debt Settlement.

The Acquiror has agreed to acquire (i) 13,872,017 Common Shares to be issued under the Debt Settlement pursuant to a debt conversion agreement at deemed price of \$0.0075 per Common Share or a total consideration of \$104,040.13; and (ii) 10,833,333 Units to be issued to the Acquiror under the Private Placement pursuant to a subscription agreement at a price of \$0.0075 per Unit or a total consideration of \$ \$37,500.00.
- b. The Acquiror's joint actor, Mr. Mintz, has agreed to acquire (i) 10,404,013 Common Shares to be issued under the Debt Settlement pursuant to a debt conversion agreement at deemed price of \$0.0075 per Common Share or a total consideration of \$78,030.10; and (ii) 2,916,667 Units to be issued to the Acquiror under the Private Placement pursuant to a subscription agreement at a price of \$0.0075 per Unit or a total consideration of \$21,875.00.
- c. The Acquiror's joint actor, Ms. Mintz, has agreed to acquire (i) 10,404,013 Common Shares to be issued under the Debt Settlement pursuant to a debt

conversion agreement at deemed price of \$0.0075 per Common Share or a total consideration of \$78,030.10; and (ii) 2,916,667 Units to be issued to the Acquiror under the Private Placement pursuant to a subscription agreement at a price of \$0.0075 per Unit or a total consideration of \$21,875.00.

The 34,680,043 Common Shares to be issued to the Acquiror and its joint actors pursuant to the Debt Settlement are to be issued to the Acquiror and its joint actors in settlement of indebtedness owed by the Company to the Acquiror and its joint actors.
