Subordinate voting shares (“**Subordinate Shares**”) and subordinate voting share purchase warrants (“**Subordinate Warrants**”) of Cresco Labs Inc. (the “**Company**”) with the head office located at 349 Beach Avenue, Kelowna, British Columbia, V1Y 5R7. Each Subordinate Warrant entitles the holder thereof to acquire one Subordinate Share at a price of \$6.0947 per Subordinate Share at any time on or before October 12, 2020.

**1.2 State the name of the market in which the transaction or other occurrence that triggered the requirement to file this report took place.**

The Subordinate Shares trade on the facilities of the Canadian Securities Exchange, under the trading symbol “CL”. The transaction giving rise to this report was the completion of a business combination (the “**Business Combination**”) that resulted in a reverse takeover of Randsburg International Gold Corp. (“**Randsburg**”) by the securityholders of Cresco Labs, LLC (“**Cresco**”), on November 30, 2018.

The closing of the Business Combination resulted in a change to the capital structure of the Company, such that (i) the existing class of common shares of the Company were redesignated as Subordinate Shares, and (ii) certain principals of Cresco were issued certain participating super voting shares. As a result of these changes, and for greater certainty, without any acquisition or disposition by the Reporter, the Reporter’s deemed beneficial ownership of Subordinate Shares and Subordinate Warrants decreased to below 10% on an undiluted and partially-diluted basis.

Prior to the Business Combination, the Reporter held 52,346,710 common shares in the capital of Randsburg (“**Randsburg Shares**”) (24.89% of the issued and outstanding Randsburg Shares), and assuming full exercise of the common share purchase warrants of Randsburg (“**Randsburg Warrants**”) prior to the Business Combination, held 70,013,377 Randsburg Shares (30.71% of the issued and outstanding Randsburg Shares on a partially diluted basis). Following the Business Combination, the Reporter holds 64,416 Subordinate Shares (0.29% of the issued and outstanding Subordinate Shares), and assuming full exercise of the Randsburg Warrants prior to the Business Combination, holds 86,156 Subordinate Shares (0.39% of the issued and outstanding shares on a partially diluted basis).

As a result of the Business Combination, the Reporter now has ownership or control over 64,416 Subordinate Shares, which represents approximately 0.29% of the issued and outstanding Subordinate Shares on an undiluted basis, and 21,740 Subordinate Warrants, which together with the 64,416 Subordinate Shares and assuming full exercise of the Subordinate Warrants, represent approximately 0.39% of the issued and outstanding Subordinate Shares on a partially diluted basis.
