### **Blackhawk Files Fiscal Year Ended June 30, 2017 Financial Reports**

Blackhawk Resource Corp. (“**Blackhawk**” or the “**Corporation**”) (BLR: TSX-V) is pleased to announce that the financial statements and MD&A for its fiscal year ended June 30, 2017 have been filed on Sedar.

- Blackhawk had interest income of \$155,051 on its debt portfolio, a realized loss on disposal of equity investments of \$102,877 and an unrealized gain on equity investments of \$2,608,400 for the year ended June 30, 2017.
- Blackhawk had cash flow from operations of \$110,835 for the year ended June 30, 2017.
- As at June 30, 2017, Blackhawk held \$5,518,859 in investments.
- As at June 30, 2017, NAV per share was \$0.13.

Blackhawk continues to hold certain equity investments, and has strategically focus its investments in eSports. As part of this focus, the equity portion of its portfolio includes a significant investment in a private eSports company, UMG Media Corp. (“UMG”). UMG has involvement in both live tournament events as well as on line match play. In 2017, UMG completed three separate equity financings at \$1.50 per share which increases the fair value of Blackhawk’s investment from \$1,358,000 to \$4,795,500.

#### **PORTFOLIO INVESTMENTS**

As at June 30, 2017, the Corporation held total investments of \$5,518,859 comprised of equity type investments of \$5,356,298 and debt type investments of \$162,561. In addition, the Corporation held a cash balance of \$30,707.
