## Blackhawk Files Quarter Ended September 30, 2017 Financial Reports

Blackhawk Resource Corp. ("**Blackhawk**" or the "**Corporation**") (BLR: TSX-V) is pleased to announce that the financial statements and MD&A for its first quarter ended September 30, 2017 have been filed on Sedar.

Blackhawk continues to hold certain equity investments and has strategically focused its investments in eSports. As part of this focus, the equity portion of its portfolio includes a significant investment in a private eSports company, UMG Media Corp. ("UMG"). UMG is involved in both live tournament events as well as on line match play. In 2017, UMG completed four separate equity financings at \$1.50 per share which increases the fair value of Blackhawk's investment from \$1,358,000 to \$4,795,500.

### PORTFOLIO INVESTMENTS

As at September 30, 2017, the Corporation held total investments of \$5,012,453 comprised of equity type investments of \$4,974,009 and debt type investments of \$38,444. In addition, the Corporation held a cash balance of \$49,564.
