The NuWave team was in Delta, British Columbia the week of September 7th looking to expand on its food stabilization capacity. There has been significant interest from large retail chains and the team at NuWave must be able to accommodate demand before entering into any commitments. Blackhawk expects to have updates on the results of these meetings and the anticipated launch of NuWave products shortly.

"We are rapidly moving towards the finish line on multiple fronts" said Frederick Pels, CEO of Blackhawk. "We have an exceptional and needed Covid-19 testing solution that covers rapid testing, PCR testing and the lab equipment itself. We are working tirelessly to get these test kits in the hands of large laboratories and private sector groups, and we look forward to sharing our progress with our shareholders in due course. In addition, NuWave has a fantastic product that I expect to see available in stores very soon. Our partnership with Specialty D Baking has been tremendous and has gotten us in front of some of the largest grocery chains in Canada. I am confident that once NuWave is able to showcase the suite of products and increase capacity, NuWave could become a much needed household staple. Preservative free, shelf stable food is an innovation that is highly in demand and NuWave is on track to become a leader in this industry."
