On August 16, 2017, the Acquiror acquired 3,000,000 Units of the Issuer at a price of \$0.02 (the "Acquisition"). 1,500,000 Units were issued to the Acquiror in connection with the settlement of an aggregate of \$30,000 of indebtedness of the Issuer. The Acquiror also subscribed for 1,500,000 Units by way of a private placement of the Issuer at a price of \$0.02.
