The Acquiror entered into an share purchase agreement (the “Share Purchase Agreement”) with Michael Gonzalez (the “Seller”) and the Company, pursuant to which the Acquiror acquired 15,300,000 Common Shares (the “Purchased Shares”) from the Seller (the “Transaction”). The Purchased Shares represent approximately 37% of the outstanding Common Shares.

15,300,000 Common Shares were acquired of by the Acquiror on April 8, 2021. Upon completion of the Transaction, the Acquiror's securityholding percentage in the Common Shares is 41%.

The Acquiror acquired 15,300,000 Common Shares which triggered the requirement to file this report.
