On June 17, 2021, the Company completed a debt settlement transaction (the "**Debt Settlement**"), whereby the Company issued, to certain creditors of the Company (including the Acquiror), an aggregate of 172,000,000 Common Shares (each, a "**Common Share**") at a deemed price of \$0.001 per Common Share in settlement of an aggregate of \$172,000.00 in indebtedness of the Company. The Common Shares issued to the creditors (including the Acquiror) were issued pursuant to separate debt conversion agreements entered into by the Company and each of the creditors.
