The transaction giving rise to this report was the completion of a business combination by way of a three-cornered amalgamation (the “**RTO Transaction**”) that resulted in the a reverse takeover of the Company by the securityholders of Hemsana Inc. (“**Hemsana**”) on July 12, 2021.

As part of the RTO Transaction, the Company consolidated its common shares (the “**Common Shares**”) on the basis of 1 post-consolidation Common Share for every 253.7067059 pre-consolidation Common Shares (the “**Consolidation**”) on June 25, 2021. Prior to the Consolidation, the Company had 269,563,375 Common Shares issued and outstanding. As a result of the

Consolidation, the Company had 1,062,501 Common Shares issued and outstanding.

The Business Combination resulted in, among other things, the increase of the Company's issued and outstanding Common Shares to be 24,129,323 upon closing on July 12, 2021. As a result, the Reporter's securityholding percentage decreased to below 10%.

Immediately before and after the Consolidation, the Reporter, with no change in shareholding percentage, held 85,640,420 pre-consolidation Common Shares, representing 31.77% of the then issued and outstanding Common Shares, which became 337,557 post-consolidation Common Shares.

Upon closing of the RTO Transaction, the Issuer had 24,129,323 Common Shares issued and outstanding. The Reporter's shareholding percentage, holding the same number of Common Shares immediately before and after closing of the RTO Transaction, has decreased to 1.40% of the issued and outstanding Common Shares.
