On February 5, 2020, the Acquirer received 30,000,000 Common Shares from the Issuer.

As previously disclosed, Ms. Julianne Nowe, 678737 N.B. Corp. and 678734 N.B. Corp., holding companies controlled by the Acquiror may be considered joint actors with the Acquiror.

On February 5, 2020, the Acquiror received 30,000,000 Common Shares from treasury pursuant to a debt settlement agreement with the Issuer.

Prior to giving effect to the issuance of Common Shares pursuant to the debt settlement agreement, Mr. Henry owned or had control or direction over an aggregate of 31,280,014 Common Shares of the Issuer representing approximately 12.49% of the issued and outstanding Common Shares.

After giving effect to the shares for debt transaction, the Acquiror owns or has control or direction over an aggregate of 61,280,014 Common Shares representing approximately 19.74% of the Issuer's outstanding Common Shares. This is an increase of approximately 7.25%. Mr. Henry has

pledged to donate certain of his holdings to the GAFF - Global Alliance Foundation Fund for the aftercare of his fellow veterans and first responders.

Assuming the exercise of 5,263,000 warrants to acquire Common Shares and 1,200,000 options to acquire Common Shares (both of which are currently out of the money), Mr. Henry would own or have control or direction over an aggregate of 67,743,014 Common Shares representing approximately 21.34% of the Issuer's outstanding Common Shares.

Mr. Henry acquired ownership or control or direction over the Common Shares.

Mr. Henry acquired the Common Shares pursuant to a debt settlement agreement with the Issuer as publicly disclosed by the Issuer on January 21, 2020.

The Common Shares were issued at a price per share of CDN \$0.05 to retire debt in the amount of CDN \$1,500,000 owed by the Issuer to Mr. Henry.

The Common Shares were acquired to retire debt owed by the Issuer to the Acquiror.
