On July 31, 2023, MTL Cannabis announced the closing of the second and final tranche of its previously announced acquisition (the "**Transaction**") effective as of July 28, 2023 of all of the issued and outstanding shares of Montréal Cannabis Médical Inc. ("**Montréal Cannabis**"). With the closing of the second tranche of the Transaction, MTL Cannabis acquired, under a share exchange agreement, approximately 75.01% of the issued and outstanding shares of Montréal Cannabis (the "**Target Shares**") in exchange for 50.01% of the issued and outstanding common shares in the capital of MTL Cannabis (the "**MTL Shares**"). As part of the Transaction and in consideration for the purchase by MTL Cannabis of its Target Shares, the Acquiror, a trust controlled by Richard Clément, received 32,703,016 MTL Shares effective July 28, 2023 at a deemed price per MTL Share of \$1.05.

The 43,238,461 MTL Shares held by the Acquiror following completion of the second and final tranche of the Transaction represent 37% of the outstanding MTL Shares on a non-diluted basis. As the Acquiror does not own any convertible securities, percentage ownership on a partially-diluted basis is identical.

The Acquiror acquired the 32,703,016 Shares for investment purposes. The Acquiror has a long term view of the investment and may acquire additional securities of MTL Cannabis including on the open market or through private acquisitions or sell securities of MTL Cannabis including on the open market or through private dispositions in the future depending on market conditions, reformulation of plans and/or other factors that the Acquiror considers relevant from time to time.
