On May 2, 2023, 2176423 Ontario acquired (the “**Acquisition**”) ownership of 2,000,000 Shares of the Corporation at a price of \$0.10 per Share. The Shares were purchased from the Corporation on a private placement basis. 2176423 Ontario is beneficially owned by Eric Sprott.

The 2,000,000 Shares acquired represent an increase in approximately 2.0% of the outstanding Shares on a non-diluted basis, from what was reported in the last early warning report. See items 2.2 and 3.4.

Mr. Sprott acquired beneficial ownership of the Shares. See item 2.2.

Prior to the Acquisition, Mr. Sprott beneficially owned or controlled 11,200,000 Shares representing approximately 17.0% of the outstanding Shares on a non-diluted basis.

After giving effect to the Acquisition, Mr. Sprott now beneficially owns and controls 13,200,000 Shares representing approximately 19.0% of the outstanding Shares on a non-diluted basis.

Mr. Spratt has a long-term view of the investment and may acquire additional securities including on the open market or through private acquisitions or sell the securities including on the open market or through private dispositions in the future depending on market conditions, reformulation of plans and/or other relevant factors. Mr. Spratt currently has no other plans or intentions that relate to or would result in the matters listed in clauses (a) to (k), above. Depending on market conditions, general economic and industry conditions, the Corporation's business and financial condition and/or other relevant factors, Mr. Spratt may develop such plans or intentions in the future.
