Management Discussion and Analysis of Financial Conditions and Results of Operations for the nine month period ended May 31, 2015

GENERAL OVERVIEW

On August 29, 2014, the Company filed articles of amendment changing its name from Applied Inventions Management Inc. to Applied Inventions Management Corp.

A cease trade order ("CTO") was imposed on the Company by the Ontario Securities Commission on February 20, 2001 for failure to file its annual audited consolidated financial statements for the year ended August 31, 2000 and interim unaudited consolidated financial statements for the three month period ended November 30, 2000. These consolidated financial statements were subsequently filed on Sedar by the Company.

On August 27, 2011 the Ontario Securities Commission issued a Revocation Order of the CTO. The Company is now seeking to complete a transaction that would allow the reinstatement of trading privileges on a recognized stock exchange.

Prior to 2002, the Company manufactured, marketed and distributed the SAVE swimming pool intrusion alarm.

The Company is in the process of reorganizing its affairs.

RESULTS OF OPERATION AND QUARTERLY RESULTS

Applied Inventions Management Corp. has incurred administrative costs, professional fees and consulting fees associated with preparing and filing annual audited consolidated financial statements, unaudited interim consolidated financial statements and all other regulatory filing requirements and has continued to accrue interest on shareholder loans. Professional fees incurred for the three month period May 31, 2015 were \$3,356 (May 31, 2014 - \$17,139). Interest accrued on shareholder loans was \$5,930 (May 31, 2014 - \$5,074). Bank charges were \$70 during the three month period ended May 31, 2015 (May 31, 2014 - \$53).

*Net Loss per share has been adjusted to reflect the 3 for 1 consolidation of each Class of shares that occurred on August 29, 2014 and the share issuance of 833,333 Class "B" shares that occurred September 2, 2014.

LIQUIDITY

The Company has been dependent upon its current controlling shareholder who is an officer and director of the Company, to provide financing for ongoing administrative expenses and for costs of re-organizing the affairs of the Company. The controlling shareholder, who is an officer and director of the Company, has indicated that he will continue to fund costs anticipated to be approximately \$15,000 per annum. However, if the current controlling shareholder decides not to fund the ongoing costs, the Company will have to attempt to raise monies to fund ongoing operations from an alternative source. There is no assurance that the Company will be able to raise the required monies at competitive rates to continue operations.

As at May 31, 2015 the Due to Shareholder amount payable, which is owing to the current controlling shareholder who is a director and officer of the Company, was \$343,154 (August 31, 2014 - \$343,154), bears no interest and is secured by a General Security Agreement (GSA). As at May 31, 2015 \$246,172 (August 31, 2014 - \$194,465) which includes accumulated interest was advanced to the Company by the same Shareholder and bears interest at 10% per annum and is secured by a GSA.

As at May 31, 2015 the Company is no longer indebted on a demand Debenture payable (August 31, 2014 - \$46,614). Interest was included in the amount owing. Interest accrued at the rate of 10% per annum, matured on November 5, 1998 and was secured by a GSA. The Debenture was in default and the conversion features which previously existed lapsed. The debenture was settled by the issuance as part of an overall settlement of debt of \$50,000 on September 2, 2014 by the issuance of 833,333 Class "B" Multiple Voting Shares.

PROPOSED TRANSACTIONS

There are currently no proposed transactions.

FINANCIAL INSTRUMENTS

All financial instruments are recorded initially at fair value. In subsequent periods, all financial instruments are measured based on the classification adopted for the financial instrument: held to maturity, loans and receivables, fair value through profit or loss ("FVTPL"), available for sale, FVTPL liabilities or other liabilities.

FVTPL assets and liabilities are subsequently measured at fair value with the change in the fair value recognized in net income (loss) during the period.

Held to maturity assets, loans and receivables, and other liabilities are subsequently measured at amortized cost using the effective interest rate method

Available for sale assets are subsequently measured at fair value with the changes in fair value recorded in other comprehensive income (loss), except for equity instruments without a quoted market price in an active market and whose fair value cannot be reliably measured, which are measured at cost.

The Company's financial instruments measured at fair value on the balance sheet consist of cash, accounts payable and accrued liabilities, shareholder advances interest bearing and non-interest bearing. These financial instruments approximate fair values due to their relatively short term maturities.

Cash is measured at level 1 of the fair value hierarchy. The Company does not have any financial instruments at level 2 or 3 of the fair value hierarchy. The three levels of the fair value hierarchy are as follows:

Level 1: Values based on unadjusted quoted prices in active markets that are accessible at the measurement date for identical assets or liabilities.

Level 2: Values based on quoted prices in markets that are not active or model inputs that are observable either directly or indirectly for substantially the full term of the asset or liability.

Level 3: Values based on prices or valuation techniques that require inputs that are both unobservable and significant to the overall fair value measurement.

FINANCIAL RISK MANAGEMENT- LIQUIDITY RISK

Risk management is the responsibility of management who is of the opinion that the Company is exposed to financial risks as described below. The Company is not exposed to currency risk or credit risk.

Liquidity risk is the risk that the Company will not be able to meet its obligations as they fall due. As at May 31, 2015 the Company had current liabilities of \$610,257 (August 31, 2014 - \$630,394) and assets of \$761 (August 31, 2014- \$6,502). As a result, the Company has liquidity risk and is dependent on obtaining additional financing to meet its current obligations.

Interest rate risk includes the risk that future cash flows or fair value will fluctuate as a result of changes in market interest rates. The Company is not exposed to interest rate risk on its shareholder loan payable which bears interest at a fixed rate.

The Company had no interest rate swap or financial contracts in place for the nine month period ended May 31, 2015 and August 31, 2014.

CAPITAL RISK MANAGEMENT

The Company considers capital stock and deficit to represent capital. As at May 31, 2015 and August 31, 2014 the Company has a negative capital balance and management's objective is to maintain its ability to continue as a going concern by identifying sources for additional financing for working capital and to fund the development of a business.

The Company is not subject to externally imposed capital requirements and there has been no change with respect to the overall capital risk management strategy during the nine month period ended May 31, 2015.

OFF BALANCE SHEET ACTIVITIES

As at May 31, 2015, the Company had no off balance sheet financial commitments and does not anticipate entering into any contracts of such nature.

RELATED PARTY TRANSACTIONS

Transactions with related parties are listed below and incurred in the normal course of business and are measured at the exchange amount:

- (a) The interest expense of \$5,930 (May 31, 2014 - \$5,074) is due to the current controlling shareholder who is a director and officer. This balance includes nil interest accrued on the debenture payable which was settled in exchange for Class "B" Multiple Voting Shares on September 2, 2014 as set out herein (2014 - \$1,059). The remaining balance \$5,930 (2014 - \$4,015) represents interest accrued on outstanding shareholder loans that are interest bearing
- (b) As at August 31, 2014 the Company had a demand debenture payable of \$46,614 consisting of principal plus accrued interest payable to the current controlling shareholder who is also a director and officer. The debenture was settled as set out above.
- (c) As at May 31, 2015 the Company has Shareholder Loans due to the current controlling shareholder, officer and director of the Company, consisting of a \$343,154 (August 31, 2014 - \$343,154) non-interest bearing advance and a \$246,172 (August 31, 2014 - \$194,465) advance bearing interest at 10% per annum, both advances being secured by a general security agreement.

CRITICAL ACCOUNTING ESTIMATES AND JUDGEMENTS

The preparation of financial statements in compliance with IFRS requires the Company's management to make certain estimates and assumptions that they consider reasonable and realistic. Despite regular reviews of these estimates and assumptions, based in particular on past achievements or anticipations, facts and circumstances may lead to changes in these estimates and assumptions which could impact the reported amount of the Company's asset, liabilities, equity or earnings. There have been no judgments made by management in the application of IFRS that have a significant effect on the financial statements for the year ended August 31, 2014. Actual results could differ from those estimates.

CONTROLS AND PROCEDURES

Management is responsible for the design of internal controls over financial reporting to provide reasonable assurance regarding the reliability of financial reporting and the preparation of the consolidated financial statements in accordance with IFRS. Based on a review of its internal control procedures at the end of the period covered by this M. D. & A., management believes its internal controls and procedures, for the nature and size of the entity, are effective in providing reasonable assurances that financial information is recorded, processed, summarized and reported in a timely manner.

Management is also responsible for the design and effectiveness of disclosure controls and procedures to provide reasonable assurance that material information related to the Company, is made known to the Company's certifying officers. Management has evaluated the effectiveness of the Company's disclosure controls and procedures and has concluded that these controls and procedures are effective, for the nature and size of the entity, in providing reasonable assurance that material information relating to the Company is made known to them by others within the Company.

OUTSTANDING SHARE DATA

Common Shares

As at May 31, 2015 the Company had 388,435 (August 31, 2014 – 388,435) Class "A" Subordinate Voting Shares and 1,139,339 (August 31, 2014 – 306,006) Class "B" Multiple Voting Shares issued and outstanding. As at July 27, 2015 no additional shares have been issued.

Share consolidation

At the Annual and Special Meeting held on June 4, 2014, the shareholders approved a consolidation of each Class of shares up to ten (10) for one (1) at the discretion of the Board of Directors. On August 29, 2014, the directors approved a share consolidation for Class "A" subordinate voting shares and Class "B" Multiple Voting shares of the Company on a basis of one (1) share for every three (3) shares outstanding of each class before any consolidation. On September 2, 2014 a shareholder who is currently the controlling shareholder, officer and director of the Company was issued 833,333 Class "B" Multiple Voting Shares as a settlement of debt owed to him of \$50,000.

Stock Options and share purchase warrants

As at July 27, 2015 there are no stock option or share purchase warrants outstanding
