The Acquiror may, from time to time, take such actions in respect of its holdings in securities of AIM, as it may deem appropriate, in light of the circumstances then existing, including the purchase of additional Class A Shares or other securities of AIM or the disposition of all or a portion of the Acquiror's shareholdings in AIM, subject in each case to applicable securities laws and the terms of such securities.
