Item 1.01 Entry into a Material Definitive Agreement.

As previously disclosed in Acreage Holdings, Inc.'s ("<u>Acreage</u>" or the "<u>Company</u>") Current Report on Form 8-K filed with the U.S. Securities and Exchange Commission (the "<u>SEC</u>") on October 31, 2022, Acreage entered into an arrangement agreement (the "<u>Floating Share Arrangement Agreement</u>") with Canopy Growth Corporation ("<u>Canopy</u>") and Canopy USA, LLC ("<u>Canopy USA</u>") and pursuant to the terms and conditions of the Floating Share Arrangement Agreement, Canopy USA will acquire all of the issued and outstanding Floating Shares as described in further detail in Acreage's definitive proxy statement and management information circular dated February 14, 2023 (the "<u>Circular</u>") filed with the SEC.

On August 31, 2023, Acreage, Canopy and Canopy USA entered into a third amendment to the Floating Share Arrangement Agreement (the "Amendment"). Pursuant to the terms of the Amendment, Acreage, Canopy and Canopy USA agreed to amend the Exercise Outside Date (as defined in the Floating Share Arrangement Agreement) from August 31, 2023 to October 31, 2023. The completion of the Floating Share Arrangement is subject to satisfaction or, if permitted, waiver of certain closing conditions, including, among others, completion of the Canopy Capital Reorganization on or prior to the Exercise Outside Date. Capitalized terms not defined herein shall, unless otherwise indicated herein, have the meanings ascribed to such terms in the Circular.

The foregoing descriptions of the Amendment is qualified in its entirety by reference to the full text of the Amendment filed as Exhibit 10.1 to this Current Report on Form 8-K ("<u>Current Report</u>").
