The Creditor and the Issuer entered into a debt conversion agreement (the "**Debt Conversion Agreement**") on July 10, 2018, pursuant to which the Creditor agreed to accept 8,884,730 Common Shares at a deemed issued price of \$0.04 per Common Share, in full settlement of \$355,389.20 of indebtedness owing to the Creditor by the Issuer (the "**Transaction**"). The Transaction closed on July 10, 2018.

The Creditor received 8,884,730 Common Shares through the settlement of an aggregate of \$355,389.20 of indebtedness at a price of \$0.04 per Common Share.

The Creditor acquired 8,884,730 Common Shares of the Issuer at a price of \$0.04 per Common Share pursuant to a Debt Conversion Agreement for aggregate cash consideration of \$355,389.20.

The 8,884,730 Common Shares were acquired through the settlement of an aggregate of \$355,389.20 of indebtedness owed to the Creditor.
