On September 21, 2018, the Issuer, Trulieve, Inc. ("**Trulieve US**") and Schyan Sub Inc. ("**Subco**") completed their previously announced merger ("**Merger**"), pursuant to which Subco merged with and into Trulieve US and Trulieve US became a wholly-owned subsidiary of the Issuer.

Item 3 - Interest in Securities of the Reporting Issuer

In connection with the Merger, the Acquiror acquired ownership and control of 19,933 Multiple Voting Shares of Trulieve Cannabis, representing 14.83% of the issued and outstanding Multiple Voting Shares. Each Multiple Voting Share is convertible into 100 Subordinate Voting Shares. Assuming conversion of all Multiple Voting Shares by the Acquiror, the Acquiror would own 1,993,300 Subordinate Voting Shares, which represents 1.82% of the outstanding Subordinate Voting Shares, assuming conversion of all outstanding Super Voting and Multiple Voting Shares.

Immediately prior to the Merger, the Acquiror did not own or control any securities of the Issuer.

in ownership of securities of the Issuer will depend on numerous conditions, including the price of the Subordinate Voting Shares and general market conditions
