Assuming conversion of all Super Voting Shares and Multiple Voting Shares by the Acquiror, the Acquiror would own 15,000,000 Subordinate Voting Shares, which represents 13.66% of the outstanding Subordinate Voting Shares, assuming conversion of all outstanding Super Voting and Multiple Voting Shares.
