The Super Voting Shares were acquired in connection with the Merger (as defined below) on September 21, 2018.

On September 21, 2018, the Issuer, Trulieve, Inc. ("**Trulieve US**") and Schyan Sub Inc. ("**Subco**") completed their previously announced merger ("**Merger**"), pursuant to which Subco merged with and into Trulieve US and Trulieve US became a wholly-owned subsidiary of the Issuer.

Item 3 - Interest in Securities of the Reporting Issuer

3.1 State the designation and number or principal amount of securities acquired or disposed of that triggered the requirement to file the report and the change in the acquiror's securityholding percentage in the class of securities.

In connection with the Merger, the Acquiror acquired ownership and control of 140,133 Super Voting Shares of Trulieve Cannabis, representing 16.44% of the issued and outstanding Super Voting Shares. Each Super Voting Share is convertible into one Multiple Voting Share, and each Multiple Voting Share is convertible into 100 Subordinate Voting Shares. Assuming conversion of all Super Voting Shares and Multiple Voting Shares by the Acquiror, the Acquiror would own 14,013,300 Subordinate Voting Shares, which represents 12.76% of the outstanding Subordinate Voting Shares, assuming conversion of all outstanding Super Voting and Multiple Voting Shares.

In addition, in connection with the Merger, the outstanding warrants of Trulieve US were exchanged for warrants to purchase Subordinate Voting Shares of the Issuer ("**Warrants**") at a price of \$6.00 per share until September 21, 2021, subject to adjustment in certain events. As a result, Jason

Pernell, who controls the Acquiror, received 1,142,033 Warrants. Assuming exercise of all Warrants and all Super Voting Shares and Multiple Voting Shares by the Acquiror and Mr. Pernell, the Acquiror and Mr. Pernell would own 15,155,333 Subordinate Voting Shares, which represents 12.77% of the outstanding Subordinate Voting Shares, assuming conversion of all outstanding Warrants, Super Voting and Multiple Voting Shares.

Immediately prior to the Merger, the Acquiror did not own or control any securities of the Issuer.

The Acquiror acquired the Super Voting Shares pursuant to the Merger. Presently, neither the Acquiror nor Mr. Pernell has any intention of acquiring any securities of the Issuer. The Acquiror and Mr. Pernell may acquire ownership of or control over further securities of the Issuer in the future depending upon market circumstances. Increase or decrease in ownership of securities of the Issuer will depend on numerous conditions, including the price of the Subordinate Voting Shares and general market conditions
