CIIH has indirect control and direction over 4,444,444 common shares of GoldTrain (the “Shares”), 250,000 options to purchase units (the “Units”) comprised of one share and one warrant with a total number of 250,000 underlying warrants to purchase shares, and 5,077,777 warrants to purchase shares (the “Warrants”) representing approximately 19.06% of the outstanding Shares on a partially diluted basis.
