Effective May 29, 2020, the Acquirer acquired ownership of or control over an aggregate of 28,000 Common Shares.

The Acquirer acquired 28,000 Common Shares, representing approximately 0.04% of the outstanding Common Shares on a non-diluted basis and approximately 0.04% on a partially diluted basis assuming exercise of the Warrants.

Prior to the Acquisition, the Acquirer owned or controlled 11,101,796 Common Shares, representing approximately 17.29% of the outstanding Shares, and 1,533,070 Warrants which, if exercised, would increase his ownership to approximately 19.22% on a post-conversion ownership basis.

After giving effect to the Acquisition, the Acquirer owns and controls 11,129,796 Common Shares, representing approximately 17.33% of the issued and outstanding Shares, and 1,533,070 Warrants which, if exercised, increase his ownership to approximately 19.26% on a post-conversion ownership basis.
