**NOTICE OF ANNUAL AND SPECIAL GENERAL MEETING

TO: The Shareholders of MOUNT DAKOTA ENERGY CORP.

4. To appoint auditors for the ensuing year and to authorize the directors to fix the remuneration of the auditors;
5. To consider and, if thought advisable, to pass an ordinary resolution of Disinterested Shareholders approving an amendment to the Company’s stock option plan; and
6. To transact such other business as may properly come before the Meeting or any adjournment or adjournments thereof.

A proxy will not be valid unless it is dated and deposited by mail or hand at the office of TSX Trust Company, (“TSX Trust”), 301 – 100 Adelaide Street West, Toronto, Ontario, M5H 4H1, not less than 48 hours (excluding Saturdays and holidays) before the time fixed for the Meeting or any adjournment thereof. Registered shareholders of the Company may also vote their proxies via the internet in accordance with the instructions provided in the proxy.

If you are a non-registered shareholder of the Company and a non-objecting beneficial owner and receive materials and a voting instruction form (“VIF”) from TSX Trust, please complete and return the VIF in accordance with the instructions of TSX Trust.

If you are a non-registered shareholder of the Company and an objecting beneficial owner and receive these materials through your broker or through another intermediary, please complete and return the materials in accordance with the instructions provided to you by your broker or such other intermediary.
