(“Baymount”) would be considered joint actors with 2364201 as a result of similar ownership and/or controlling parties, and that 2364201 and its joint actors then beneficially owned 10,004,028 Common Shares, representing approximately 42.53% of the issued and outstanding voting securities of the Issuer on a fully-diluted basis. For purposes of this report, 2364201 is not a joint actor with SimKap or Baymount and has no control or direction over any Common Shares owned by either such entity.
