

## **CORDOVACANN ANNOUNCES OPENING OF FIRST STAR BUDS CANNABIS RETAIL STORE IN ONTARIO**

**TORONTO, ONTARIO, June 9, 2020**, CordovaCann Corp. (CSE: CDVA) (OTCQB: LVRLF) (“Cordova” or the “Company”), a cannabis-focused consumer products company, is pleased to announce that its first Star Buds branded cannabis retail store in Ontario has received confirmation from the Alcohol and Gaming Commission of Ontario that it can open today. This store is located at [181 Livingstone Street East, Unit 3, in the city of Barrie](#), and is operated by Cordova’s subsidiary, 2734158 Ontario Inc. (“273”). This is the first of many Star Buds cannabis retail stores to be opened across Canada by Cordova, and the Company expects to open additional stores in the coming months.

This Star Buds branded store will start processing orders for curbside pickup from customers that are made through its website [www.starbuds.co](http://www.starbuds.co), and will also be open to walk-in customers on June 13, 2020. This store will provide customers with a wide variety of products specifically curated for their needs, including flower, edibles, extracts, pre-rolls, vape pens, topicals, and tinctures, as well as branded merchandise.

“We are very excited to open our first Star Buds retail store in Barrie, and the ability to do so on such a quick timeline is a testament to our team on the ground,” stated Taz Turner, Chairman and CEO of Cordova. “We continue to work towards opening new stores and look forward to sharing our progress with both investors and consumers.”

Chris Jones, Co-founder and President of 273 commented, “We are pleased with our current momentum and look forward to migrating cannabis sales from the illicit to the regulated market. Increasing our presence in underserved regions is an important step for the continued growth of the Star Buds brand in Ontario.
