Introduction

This Management Discussion and Analysis Report has been prepared to provide material updates and analysis of the business operations, financial condition, financial performance, cash flows, liquidity, and capital resources of Mineworx Technologies Ltd. (formally Iberian Minerals Ltd.) and its subsidiaries (“Mineworx” or the “Company”).

The information provided herein should be read in conjunction with the Company’s unaudited condensed audited consolidated financial statements and the notes thereto for the six months ending June 30, 2020, and the Annual MD&A for the year ending December 31, 2019.

The statements have been prepared in accordance with International Financial Reporting Standards (“IFRS”).

Mineworx is listed on the TSX Venture Exchange under the symbol “MWX”, on the OTCQB Exchange under the symbol “MWXRF” and on the Frankfurt Stock Exchange under the symbol “YRS”. The Company is engaged in the development and deployment of innovative material processing technologies and the exploration, acquisition and development of mineral properties.

Except as otherwise disclosed, all dollar figures in this report are stated in Canadian dollars. The effective date of this report is August 27, 2020.

Corporate Overview

In June 2017, the Company officially changed its name to Mineworx Technologies Ltd. to better reflect the changed business focus. In late 2015, the Company implemented a strategy to pursue and investigate a new paradigm being created in the mining sector to complement its Spanish mineral assets and current business model.

In December 2015, the Company acquired Mineworx Technologies Inc., who developed the HM X-tract, a unique, patent-pending, portable, heavy mineral extraction process and an innovative new business model for the gold and precious metals mining sector. As of June 30, 2018, Mineworx Technologies Inc. and Iberian Minerals Ltd. were amalgamated into one company the Mineworx Technologies Ltd. name.

The Mineworx business model is to seek out advanced-stage mineral deposits on which to employ its portable processing technologies, and to partner with the existing owners and operators to advance these deposits to profitable production in a timely and cost-efficient manner. The model offers operators accelerated production timelines, lower cut off grades, reduced infrastructure, shorter permitting periods, improved market valuations, and lower the operating costs, environmental impact and the economic risks.

The unique, integrated water clarification and filtration technologies allows operators to recycle most of the process water used at a typical mine site. This conserves water, minimizes environmental discharge and significantly reduces or eliminates the necessity for tailings ponds.

As part of the strategic review the Company decided to spin out the HM X-leach technology to the newly formed public entity Enviroleach Technologies Inc. in the first quarter of 2017. This transaction allowed for the shareholders of Mineworx to continue to share in the promising upside of the technology while the Company focused on the development of the Mineworx business model.

On March 21, 2017, the Company finalized an arrangement involving Mineworx, shareholders of Mineworx and Enviroleach. The plan of arrangement involved the spin-out of the Mineworx 'Technology Rights' to Enviroleach and the distribution to the Company's shareholders of 25,999,813 common shares of Enviroleach.

Under the terms of the Arrangement Agreement, through a statutory plan of arrangement under the Business Corporations Act (Alberta) (the "Arrangement"), the Company transferred the Technology to Enviroleach in exchange for total compensation of \$8,600,000 comprised of:

- i) 28 million common shares of Enviroleach valued at \$0.25 per share,
- ii) promissory notes in the amount of \$1,600,000 made by Enviroleach in favour of the Company carrying a 5% interest rate. At June 30, 2020 \$250,000 remains unpaid.
- iii) The Company will retain a license agreement in perpetuity for the Enviroleach, patent-pending, non-cyanide gold leaching solution for its' mining applications.

After working in conjunction with Enviroleach it was realized that utilizing the Mineworx technologies and expertise enhanced recoveries of precious metals in E-Waste material during the Enviroleach process. With this knowledge Enviroleach and Mineworx agreed to create a Joint Venture to pursue opportunities in the E-Waste sector. The Mineworx equity share of the joint venture is 20%.

Participation in the joint venture caused the focus of Mineworx to change from the mining industry to the E-waste sector. The management of Mineworx believes that this new sector offers an accelerated route to profitability. After the successful implementation of the E-waste strategy the company will resume pursuing opportunities in the mining industry.

Overall Performance

The Company has been focused on the advancement of the catalytic converter business which has included laboratory work to increase the effectiveness and economics of the process. The lab work is providing the baseline data required to design the processing plant. The lab has been utilizing samples provided from our supply partner Davis Recycling.

The Company announced a Letter of Intent with Enviroleach Technologies for a license agreement related to recovering Platinum Group Metals from catalytic converters in the first quarter and has been working in conjunction with Enviroleach to complete a definitive agreement.

In the six months ending June 30, 2020 the Company completed its portion of the fabrication work for the Vancouver E-waste joint venture facility. The joint venture reported producing 19.4 tonnes of mineral rich concentrates during testing and commissioning and performed comprehensive full-scale production testing of over 60,000 lbs of E-waste material provided by Jabil Inc. at the Vancouver facility.

Exploration and Evaluation Assets

Management has worked diligently to identify mineral resource properties that indicated potential for commercial ore bodies. Exploration programs and technical studies aimed at determining the existence, grade, and economic feasibility of mineral deposits are being carried out. Mining activities are generally required to comply with varying levels of regulatory and environmental requirements that vary by jurisdiction.

All necessary documentation to increase the size of the Cehegin iron ore concession has been submitted. The work necessary to submit for a work/drill program permitting was completed. This work will commence when Spanish government approvals are received. Due to the restrictions put in place from the COVID outbreak Spanish government activities have been substantially delayed.

The Cehegín Iron Ore Concessions, Spain

Mineworx wholly-owned subsidiary, Solid Mines Espana, S.A.U. (“SME”), through the wholly owned subsidiary Magnetitas del Cehegín, S.L., (“MDC”), holds all of the rights and interests associated with the Cehegin 62 iron ore concessions in south-eastern Spain. In total the Cehegin iron ore property represents 62 exploitation concessions representing a surface area of 1,030 hectares. The Company has applied for an expansion of the local area creating a continuous area of 6,900 hectares. In September 2015, Mineworx regained a 100% interest in Cehegin Iron Ore Holdings, S.L. (“CIOH”) the Spanish holding company formed under the terms of the Joint Venture Agreement (“the JVA”) with Glencore International AG (“Glencore”). By mutual agreement, Mineworx through SME has acquired Glencore’s 20% interest in CIOH for nominal consideration and now maintains 100% ownership in the Cehegin Iron Ore Project located in the Province of Murcia, south-eastern Spain. In connection with the acquisition of Glencore’s 20% interest in CIOH, each of the parties has agreed to terminate all agreements related to the JVA, with the exception of Glencore’s exclusive off-take agreement, which will remain in effect. In 2018 CIOH was amalgamated into MDC.

SME will be required to pay an additional amount of up to €2,700,000 once a mining permit is submitted and granted for all 62 concessions, an improvement over the previously announced cost of €3,000,000. If SME proceeds with the new magnetite mining project, this additional payment would be made within four months from the decision notice date on which the permits or licenses are issued. This additional amount will be reduced to €1,800,000 if SME proceeds with the project, but does not obtain all mining permits for the total 62 concessions in its initial submission. No net royalties will be due on any proceeds from commercialization of the project.

The magnetite concessions are located in the province of Murcia, region of Cehegín, in the triangle formed by the towns of Calasparra, Cehegín and Mula in south eastern Spain. The concessions were formally owned by the Spanish ironworks company, Altos Hornos de Vizcaya, which was the largest industrial company in Spain for much of the twentieth century. In 1975, all 62 concessions were grouped together in one single subsidiary of Altos Hornos de Vizcaya called Agrupacion Minera, SA who exploited one of the open pit mines – Mina Maria, for its own needs until 1985.

The 62 separate concessions, which were mined for iron ore during the 20th century, offer excellent infrastructure, including hydro, water and a railway, approximately 12 km away, connecting at the rail station in the municipality of Calasparra, to the deep-sea port of Cartagena, 100 km away.

Production can commence on the existing permitted concessions upon the Company updating the viability and environmental studies to the satisfaction of the local mining and environmental authorities and upon suitable financing being available.

The Company’s Spanish Geological team has analyzed the 38,000 meters of historical drilling on the Cehegin Iron Ore concessions. 100% of the drill holes on three of the 62 concessions have been digitized allowing for the completion of 3D modelling. The Company’s analysis confirms a vast expansion of the ore bodies which are open in all directions including depth.

The Cehegín iron ore concession has a good infrastructure and access by rail to the deep-sea Port of Cartagena, 104 Km away from the property. The concession is located in the south-eastern area of the mineral rich Iberian Peninsula; this region has a long history of iron ore production that was once the dominant supplier to all of Europe. The Company was able to obtain all of the detailed historical mining and exploration data, compiled by the previous operational owner, Altos Hornos de Vizcaya. This valuable data will result in significant savings in exploration costs and advance the timeline to production.

The Company completed a high-resolution aeromagnetic survey during the spring of 2015. The main objectives of the airborne survey were to confirm and define the extent of several additional targets that have been identified through the data compilation program. The survey provided excellent resolution of near-surface magnetic sources, representing a major improvement over prior regional aeromagnetic data. In particular, many of the stronger, better defined, discrete magnetic anomalies correspond to known iron ore (Fe) mines and prospects, such as the important Soledad and Colossus prospects. Most magnetic sources are judged to be quite shallow, or at least have a very shallow, sub-cropping portion. The Company has received a technical report (NI 43-101) for the Cehegín property, prepared by Stanley C. Bartlett M.Sc., PGeo of Micon International Co Limited, in the United Kingdom, dated April 28, 2014, which has been filed on SEDAR at www.sedar.com on May 20, 2014.

The Aroche Wollastonite Project, Spain

Under the terms of the three-year option agreement, ending November 6, 2019, Iberian Minerals will be responsible to pay all exploration, G&A plus capital expenditures and governmental fees on Aroche.

The Company will make a onetime cash payment of €100,000 to the Optionor once the exploitation permit for Aroche has been obtained. Iberian Minerals has the right to terminate the agreement at its discretion at any time with no penalties. The Optionor will maintain a 10% interest in Aroche. The option agreement allows for an extension of the three-year term in the event of unintentional causes of delay relating to Iberian completing its due diligence, investigation of mineral extensions, confirmation of historical estimates and exploitation permitting of the wollastonite.

Aroche was previously investigated by the National Mining Investigations Company Adaro, S.A. (“ENADIMSA”) between 1983 – 1988, which included mechanical drillings, trenching, blasting and mineralogical studies determining the existence of an important marble quarry and wollastonite. At the time wollastonite was not a target mineral.

An Exploitation Permit for the marble resource was granted for Aroche on January 23, 1991 for a period of thirty (30) years that can be extended ninety (90) years until 2081. Marble was exploited on the property by the Optionor from 1991 to 2003. Recognizing the importance of the wollastonite deposit during this period, the Optionor designed and planned a conceptual concentration system and mineralogical plant for the processing of the wollastonite which included crushing, grinding, flotation, dense media and High Intensity Magnetic Separation (“HIMS”).

The current Aroche Marble Exploitation Permit could be authorized to include wollastonite, as a result of the previous extensive investigation on the property which has an estimated cost of over €3 Million in relative value today. The Company’s Spanish technical team is currently evaluating the historical data on Aroche and will release additional information on the potential of the project in the near future.

During the due diligence process required to complete this transaction, some issues arose that the vendor was required to address and resolve, which, as at June 30, 2020 had not been done. During the 2019 year, the vendor filed a lawsuit to compel the Company to complete the transaction. The Company believes this lawsuit has no merit and has not provided a provision of €394,850, which is the amount stated in the lawsuit.

Fluctuations in the Company's expenditures reflect the variations in the timing of exploration and development activities, general corporate operations, the timing of share-based payments, and write-down or sale of certain exploration, evaluation, or other assets.

Financial results

The Company had no operating revenue for the six months ending June 30, 2020 and 2019. For the six months ending June 30, 2020, the Company incurred a net loss of \$1,484,730 (2019 – loss of \$1,127,989)

Total expenses of \$869,624 related general administration and sales in the six months ending June 30, 2020 (2019 - \$530,650).

Consulting fees were \$48,843 (2019 - \$41,863), primarily relates to general services in Spain to support the exploration projects located there.

Investor relations were \$31,106 (2019 - \$65,905), the decrease relates to less spending related to informing the market of the change in focus for the company than in 2019.

Interest costs were \$22,066 (2019 - \$24,329), primarily relates to leases and sub-leases held by the company.

Management and employee costs were \$348,283 (2019 - \$256,097), the increase is a result of completing the fabrication work for the E-waste joint venture which was reimbursing a portion of these costs in 2019. The employee costs were offset by \$104,428 received from government COVID grants that are included in Other income.

Office and general costs were \$73,410 (2019 - \$63,979), there was a small increase in spending on supplies and services in 2020.

Professional fees were \$35,417 (2019 - \$30,146), relate to general corporate services in Canada and Spain.

Project costs were \$287,529 (2019 - \$4,431), the increase is related to work and setups related to the catalytic converter project.

Travel costs were \$5,824 (2019 - \$29,047), the decrease is a result of less activities related to investor relations than in 2019.

The loss of \$151,477 (2019 – loss of \$19,224) on securities held for sale resulted from the Enviroleach Technologies shares. The Company sold all the 931,482 shares that it held for proceeds of \$1,059,450 which was less than the \$1.30 per share valuation as of December 31, 2019.

The Company interest income of \$6,264 (2019 – \$34,860) primarily related to interest on the notes due from Enviroleach, the note balance is lower when compared to the same period in 2019.

The Company recognized a gain of \$17,751 (2019 – loss of \$88,561) on foreign currency related primarily to the Euro.

\$263,166 was expensed as amortization in 2020 (2019 - \$280,363), \$142,760 (2019 - \$142,760) related to the amortization of the intangible assets and \$120,405 (2019 - \$133,685) was for equipment depreciation. The reduction of depreciation expense resulted from some of the assets being fully depreciated.

In 2020 the Company recognized a loss of \$361,443 (2019 - \$306,743) related to its 20% minority interest in the E-Waste joint venture. The joint venture had total losses of \$1,807,215 (2019 - \$1,533,715)

Quarterly Financial Information

In the quarter ending June 30, 2020, the company incurred a loss of \$522,666 (2019 - \$396,085), There was no revenue from operations in the quarter.

Total expenses for general administration in the six months ending June 30, 2020 were \$412,700 (2018 - \$219,422).

Project costs of \$176,208 (2019 - \$2,412) relating primarily to the advancement of the catalytic converter project represent the majority of the cost increases.

The company received \$104,428 (2019 - \$nil) in COVID grants from the government that offset the \$139,425 in management and employee costs. The grants were reported in Other income.

The company recognized a loss of \$97,413 (2019 – gain of \$68,586) on the disposition of the remaining Enviroleach shares.

The Company recognized a loss of \$17,614 (2019 – loss of \$68,586) on foreign currency related primarily to the Euro.

The company recognized a loss of \$190,453 (2019 - \$100,810) related to its 20% minority interest in the E-waste joint venture. The joint venture had total losses of \$952,265 (2019 - \$504,050) in the quarter ending June 30, 2020.

Exploration and Evaluation Assets

For the six months ending June 30, 2020, the Cehegin total expenditures were \$7,657 (2019 - \$15,727), comprised of geological fees and expenses of \$2,200 (2019 - \$4,024), mining rights and taxes of \$3,234 (2019 - \$3,946), and field costs of \$2,223 (2019 - \$7,757). Cehegin was the only property development advanced in 2020. Decreased spending is a result of the COVID situation in Spain during the period and the restrictions it imposed in that country.

Equipment

For the six months ending June 30, 2020, the expenditures on equipment was \$9,405 (2019 - \$33,249) for equipment required for the catalytic converter project. The 2019 expenditures included \$21,561 for a shop truck.

Intangible Assets

The 2020 balance is \$1,331,177 (2019 - \$1,473,937) the reduction is due to the amortization of \$142,760 (2018 - \$142,760) charged against the account.

The majority of the intangible asset is the technology asset acquired as part of the Mineworx transaction.

Liquidity and Capital Resources

At June 30, 2020, the Company's cash position was \$1,106,935 (2019 - \$1,198,288) and the working capital was \$1,070,466.

Net cash used in operating activities for the six months ending June 30, 2020 was \$641,015 (2019 - \$936,536), which relates primarily to general and administrative expenses.

Net cash used in investing activities for the six months ending June 30, 2020 was \$105,586 (2019 - \$705,988). The company contributed \$88,525 (2019 - \$656,295) to fund the operation on the E-Waste joint venture.

Net cash provided by financing activities for the six months ending June 30, 2020 was \$1,608,773 (2019 - negative \$55,893). The Company received \$1,059,450 (2019 - \$nil) from the sale of securities and \$420,000 (2019 - \$nil) in proceeds from a private placement. \$160,000 (2019 - \$nil) of debt was issued by the Company. Proceeds from sub-leases of \$144,436 (2019 - \$78,038) was offset by equipment lease payments of \$175,113 (2019 - \$133,931). The lease payments were reduced by \$26,097 due to COVID reductions.

The Company is in an exploration and development phase and is not generating revenue as of yet, it is expected that the working capital balance will follow a cycle of reduction and replenishment. Management currently follows a policy of raising only sufficient capital to carry out its near-term plans. This policy is meant to minimize dilution of shareholders' positions by raising capital when the stock price is at higher levels.

Capital Commitments

The Company had no commitments for property and equipment expenditures for fiscal 2020. The Company expects that any property and equipment expenditures incurred, based on future needs, will be funded from working capital and/or from operating or capital leases.

Changes in Accounting Policies Including Initial Adoption

Future Accounting Pronouncements

A number of new standards, amendments to standards and interpretations, described in the notes to the condensed interim consolidated financial statements, are not yet effective as of the date of this report, and were not applied in preparing the condensed interim consolidated financial statements. The Company is currently assessing the impact that these standards will have on the condensed interim consolidated financial statements.

Financial Risk Management

International Financial Reporting Standards 7, *Financial Instruments: Disclosures*, establishes a fair value hierarchy that reflects the significance of the inputs used in making the measurements.

At June 30, 2020, the carrying values of cash, receivables and accounts payable and accrued liabilities approximate their fair values due to their short terms to maturity.

Financial risks

The Company has exposure to the following risks from its use of financial instruments:

- Credit risk
- Liquidity risk
- Market risk

Credit risk

The Company's credit risk is primarily attributable to cash and receivables. The Company has no significant concentration of credit risk arising from operations. Cash consists of chequing accounts at reputable financial institution, from which management believes the risk of loss to be remote. Federal deposit insurance covers balances up to \$100,000 in Canada. Financial instruments included in receivables consist of amounts due from government agencies. The Company limits its exposure to credit loss for cash by placing its cash with high quality financial institution and for receivables by standard credit checks. At June 30, 2020, the Company's exposure to credit risk is minimal.

Liquidity risk

Liquidity risk is the risk that the Company will not be able to meet its financial obligations as they fall due. The Company has a planning and budgeting process in place to help determine the funds required to support the Company's normal operating requirements on an ongoing basis.

As at June 30, 2020, the Company had a cash balance of \$1,016,935 (2019 - \$154,763) to settle current liabilities of \$483,247 (2019 - \$564,153).

Historically, the Company's sole source of funding has been the issuance of equity securities for cash, primarily through private placements and loans from related and other parties. The Company's access to financing is always uncertain. There can be no assurance of continued access to significant equity funding

Market risk

Market risk is the risk of loss that may arise from changes in market factors such as interest rates, foreign exchange rates, and commodity and equity prices.

a) Interest and foreign exchange risk

The Company is subject to normal risks including fluctuations in foreign exchange rates and interest rates. While the Company manages its operations in order to minimize exposure to these risks, it has not entered into any derivatives or contracts to hedge or otherwise mitigate this exposure. At June 30, 2020, the Company was not exposed to significant interest rate risk.

The Company has significant operating expenditures which are denominated in Euro ("EUR"). The Company's exposure to exchange rate fluctuations arises mainly on foreign currencies against the Canadian dollar functional currency of the relevant business entities. The Company is principally engaged in the acquisition, exploration and development of mineral properties in Spain.

Sensitivity analysis

The Company is exposed to foreign currency risk on fluctuations related to cash, and accounts payable and accrued liabilities that are denominated in Euro. As at June 30, 2020, net financial assets totalling \$33,468 (2019 - \$51,187) were held in Euro. This excludes \$306,100 (2019 - \$286,438) held as security and listed as restricted cash in the financial statements as well as intercompany loans.

For US dollars, there was a net financial asset of \$293,048 (2019 - net financial liability of \$16,678).

As at June 30, 2020 and assuming all other variables remain constant, a 2% depreciation or appreciation of the Euro against the Canadian dollar would result in an increase or decrease of approximately \$45,249 (2019 - \$40,664) in the Company's loss and comprehensive loss. A similar variation in the US dollar would have negligible affect.

b) Price risk

The Company is exposed to price risk with respect to commodity and equity prices. Equity price risk is defined as the potential adverse impact on the Company's earnings due to movements in individual equity prices or general movements in the level of the stock market. Commodity price risk is defined as the potential adverse impact on earnings and economic value due to commodity price movements and volatilities. The Company closely monitors commodity, individual equity movements, and the stock market to determine the appropriate course of action to be taken by the Company.
