Management's discussion and analysis for the years ended December 31, 2023 and 2022

#### GENERAL

The following discussion of performance, financial condition and prospects of New Frontier Ventures Inc. (the "Company", a publicly listed Corporation on the Canadian Stock Exchange or "CSE")) should be read in conjunction with the audited consolidated financial statements for the period ended December 31, 2023 ("Financial Statements"), and management discussion and analysis for the year ended thereon. The Company's Financial Statements have been prepared in accordance with International Financial Reporting Standards ("IFRS"). The Financial Statements and the Management Discussion and Analysis ("MD&A") have been reviewed by the Audit Committee and approved by the Company's Board of Directors on June 7, 2024. The Canadian dollar is the functional and reporting currency of Gravitas. Unless otherwise noted, all dollar amounts within this report are expressed in Canadian dollars. In addition to reviewing this report, readers are encouraged to read the Company's public filings on SEDAR at www.sedar.com.

## **CORPORATE OVERVIEW**

New Frontier Ventures Inc. (Formerly "Gravitas Financial Inc.") (the "Company") was an investment holding firm. It disposed of its assets in 2019 to 2021 and is currently looking for new business. The Company is a publicly listed company on the Canada Securities Exchange ("CSE") and was trading under the symbol, VFI-X.

The Company was incorporated under the Canada Business Corporation Act with its registered office and principal place of business at 200 Consumers Road, Suite 702, Toronto, Ontario, M2J 4R4.

These Consolidated Financial Statements ("Financial Statements") were approved by the Board of Directors on June 7, 2024.

## **Going Concern**

These Financial Statements have been prepared on a going concern basis, which assumes the Company will continue its operations in the foreseeable future and that it will be able to realize its assets and discharge its liabilities in the normal course of operations. As of December 31, 2023, the Company's current liabilities exceed current assets by 420,603 (2022 - \$428,934). The Company as of December 31, 2023, has a cumulative deficit of \$6,786,878 (2022 - \$6,618,957); negative cash flows from operations for the year ended December 31, 2023 totaling \$1,169 (2022 - \$35,828); and has a shareholder deficiency of \$420,603 as at December 31, 2023 (2022 - \$428,934). These conditions indicate the existence of material uncertainties that may cast significant doubt on the Company's ability to continue as a going concern. The consolidated financial statements do not reflect adjustments to the carrying value of assets and liabilities or reported expenses and statement of financial position classifications that would be necessary if the going concern assumption was not appropriate. These adjustments could be material.

Management's discussion and analysis for the years ended December 31, 2023 and 2022

Management is pursuing initiatives intended to address the current working capital deficiency. Due to the continuing operating losses, the Company's ability to continue as a going concern is dependent upon its ability to obtain adequate financing and to reach profitable levels of operation. It is not possible to predict whether financing efforts will be successful or if the Company will attain profitable levels of operation. Management believes it will be successful In obtaining necessary funding to continue operations in the normal course of operations. However there is no assurance that these funds will be available on terms acceptable to the Company.

Management of the Company had been successful in liquidating some of its assets to pay the liabilities.

#### SELECTED FINANCIAL INFORMATION

As at December 31, 2023, the total liabilities of the Company were \$423,023 compared to \$447,877 at December 31, 2022.

Shareholder total equity deficiency of the Company was \$420,063 as at December 31, 2023 compared to \$428,934 at December 31, 2022.

On July 7, 2023 the Company closed the settlement of \$211,994 debt owed by the Company to three service providers by issuing 4,239,880 common shares of the Company at \$0.045 per share, including 3,200,000 common shares issued to two directors of the Company to settle \$160,000 owed to them. \$21,199 gain on the debt settlement was recorded representing the difference between the fair price of the shares and the debt amount settled. \$14,543 legal costs were recorded as share issue costs. Legal costs plus HST in total of \$18,990 was forgiven by the service provider that was recorded as gain on forgiveness of debt.

#### For the year ended December 31, 2023

The operations reported \$nil revenue for the years ended December 31, 2023 (2022 - \$nil), a net loss of \$167,921 (2022 - \$163,896) and a net loss per share of \$0.03 (2022 - \$0.06).

For the year ended December 31, 2023, the Company incurred \$85,219 (2022 - \$95,690) for compensation and management fees, \$44,687 (2022 - \$26,070) consulting and professional fees, incurred \$52,431 (2022 - \$35,592) general and administrative expenses, and recorded \$7,502 (2022 - \$6,198) interest and bank charges expenses. The Company also reported \$nil (2022 - \$162) foreign exchange loss, and \$40,189 from gain on forgiveness and settlement of debts.

In the period ended December 31, 2023 the Company sold investment asset and received \$1,729 for a gain of \$1,729 (2022 - loss of \$184).

In the years 2023, the Company received \$10,671 (2022 - \$28,000) advances from directors and related parties.

#### RELATED PARTIES AND RELATED PARTY TRANSACTIONS

Parties are considered related if the party has the ability, either directly or indirectly, to control the other party or exercise significant influence over the other party in making operating and financial decisions. This would include the Company's and their subsidiaries' senior management. Parties are also related if they are subject to common control or common significant influence. Related parties may be individuals or corporate entities. A transaction is a related party transaction when there is a transfer of resources or obligations between related parties. The following are the related party transactions during the periods ended December 31, 2023 and 2022. Unless otherwise stated, none of the transactions incorporated special terms and conditions and no guarantees were given or received. Usually outstanding balances are settled in cash.

During the period ended December 31, 2023, the Company-

- Incurred \$84,000 (2022- \$90,000) of fees to senior officers of the Company, including the Chief Executive Officer and Chief Financial Officer. This amount has been included in compensation and management fees. \$245,794 (2022 \$328,054) was outstanding at December 31, 2023 and included in the trade and other payables. In the year 2023, 3,200,000 common shares were issued to two officers of the Company to settle \$160,000 owed to them.
- In the period ended December 31, 2023, three directors advanced \$10,671 (2022 \$28,000) to support the working capital that is interest free, unsecured and due on demand. The outstanding balance was \$38,671 as of December 31, 2023 (2022 \$28,000).

## **STOCK-BASED COMPENSATION**

The Company has adopted a stock-based option plan under which the Board of Directors may award options for common shares to directors, officers, employees and consultants. The maximum number of common shares issuable pursuant to the share option plan must not exceed 10% of the total number of the Company's outstanding. The exercise price of each option is determined by the Board of Directors and cannot be less than the discounted market value of the common shares on the eve of the award. The term of the options cannot exceed five years. There was no stock option is outstanding as of December 31, 2022 and December 31, 2023.

## **SUMMARY OF SHARES OUTSTANDING**

As at December 31, 2023, the Company's authorized share capital consists in an unlimited number of common shares of which 7,143,962 are currently outstanding. There was no options outstanding as of December 31, 2023.

## BASIS OF CONSOLIDATION OF THE COMPANY'S FINANCIAL STATEMENTS

The Financial Statements include the accounts of the Company and its subsidiaries. Subsidiaries are entities which the Company has power over decisions about relevant activities. The existence and effect of potential voting rights that are currently exercisable, or convertible are considered when assessing whether control exists. Subsidiaries are fully

consolidated from the date on which control is transferred to the Company. Entities are deconsolidated from the date on which control ceases. Accounting policies of subsidiaries have been changed, where necessary, to ensure consistency with the Company's policies. The purchase method of accounting is used to account for the acquisition of subsidiaries. Purchase consideration is measured as the fair value of the assets given, equity instruments issued, and liabilities assumed at the date of exchange. The transaction costs directly attributable to the acquisition are expensed.

## **CRITICAL ACCOUNTING ESTIMATES AND MATERIAL ACCOUNTING POLICIES**

The preparation of the Financial Statements requires the Company to make judgments in applying its accounting policies and estimates and assumptions about the future. Judgments, estimates and assumptions affect the Company's reported amounts of assets, liabilities, and items in net income or loss, and related disclosure. Estimates are based on various assumptions that the Company believes are reasonable under the circumstances. These estimates form the basis for making judgments about the carrying value of assets and liabilities and the reported amounts of items in net earnings or loss that are not apparent from other sources. The Company evaluates its estimates on an ongoing basis. Actual results may differ from the Company's estimates. Please refer to the Note 3 to the December 31, 2023 consolidated financial statements for the estimates and assumptions that may have significant effects.

## STANDARDS, AMENDMENTS, AND INTERPRETATIONS ISSUED AND ADOPTED

The Company has adopted effectively from January 1, 2023 the follow new standards and amendments. The adoption of the standards and amendments has no impact on the consolidated financial statements of the Company.

IAS 1 – Presentation of Financial Statements ("IAS 1") was amended in January 2020 to provide a more general approach to the classification of liabilities under IAS 1 based on the contractual arrangements in place at the reporting date. The amendments clarify that the classification of liabilities as current or noncurrent is based solely on a company's right to defer settlement at the reporting date. The right needs to be unconditional and must have substance. The amendments also clarify that the transfer of a company's own equity instruments is regarded as settlement of a liability, unless it results from the exercise of a conversion option meeting the definition of an equity instrument. The amendments are effective for annual periods beginning on January 1, 2024.

#### RISKS RELATED TO FINANCIAL INSTRUMENTS

The Company is exposed to the following risks through its financial instruments.

## Credit risk

Credit risk is the risk that one party to a financial instrument will cause a financial loss for the other party by failing to discharge an obligation. The Company's trade and other receivables are subject to the expected credit loss model. The Company applies the simplified approach to providing for expected credit losses prescribed by IFRS 9, which permits the use of the lifetime expected loss provision for all trade and other receivables and receivables from brokers and clients, while ECL calculation based on stage assessment has been performed for loan receivables.

## Liquidity risk

Liquidity risk is the risk that the Company will encounter difficulties in meeting obligations with financial liabilities that would be settled either by delivering cash or another financial asset. See Note 2 for Going Concern uncertainty. The Company has current assets of \$2,420 which will be used to cover its operating and investing activities. The expected timing of consolidated cash flows relating to financial liabilities as at December 31, 2023, are as follows:

#### Market risk

Market risk is the risk that the fair value or future cash flows of a financial instrument will fluctuate because of changes in market prices. The Company is exposed to the following three types of market risk: interest rate risk, currency risk and other price risk.

Interest rate risk - Interest rate risk is the risk that the fair value or future cash flows of a financial instrument will fluctuate because of changes in market interest rates. The Company is not exposed to significant interest rate risk as the loan payable is interest free.

## **LOAN PAYABLE**

On June 2, 2020, the Company obtained \$40,000 in revolving credit from the Government of Canada under the Canada Emergency Business Account (CEBA) COVID-19 Economic Response Plan. The funding is granted in the form of an interest free revolving credit line of which up to \$40,000 may be drawn. On January 1, 2021, any balance remaining on the revolving credit line will automatically convert into a non-revolving term loan. Effective January 1, 2023, any outstanding balance on the term loan shall bear interest at a rate of 5% per annum. The term loan matures on December 31, 2025. If 75% of the outstanding balance of the term loan is repaid on or before December 31, 2022, the remaining 25% of the balance shall be forgiven. The Company used the assumption of 20% discount rate to determine the fair value of the interest-free period, and assumes the Company will repay the 75% outstanding balance on December 31, 2022. The difference between the amount received in cash and the related fair value was considered a government grant and was recognized as income in the statement of income.

The Company drew the full \$40,000 and intended to repay \$30,000 on or before December 31, 2022. The initial recognition of the \$40,000 was at its fair value at a discount of 20%. \$18,665 was recognized as debt and \$21,335 was recognized as government grant income.

In 2021 the Canadian Government increased the CEBA loan available to small businesses to \$60,000. The Company made another draw of \$20,000 on January 11, 2021. If the Company would repay the outstanding balance of the loan (other than the forgiven amount) on or before December 31, 2022, the forgiven amount would be \$20,000 in total (25% of the first \$40,000 and 50% of the second \$20,000). The Company recorded the \$12,903 of the \$20,000 as government grant income, and \$7,097 as new loan portion.

In late 2021, the Canadian Government extended the date of repayment for the forgiven amount from December 31, 2022 to December 31, 2023. As a result, the Company recorded another \$5,695 government grant income for 2021.

\$6,667 interest was accrued for the year ended December 31, 2023 (2022 - \$5,555). Subsequent to December 31, 2023, the Company was not able to repay the \$40,000 amount required before the deadline of January 18, 2024, and the Company adjusted the loan balance as of December 31, 2023 to \$60,000 (2022 - \$33,333) and recorded a reversal of government grant of \$20,000 for the year ended December 31, 2023 (2022 - \$nil). Effective January 18, 2024 the loan became a term loan bearing annual interest rate of 5% that matures on December 31, 2026.

#### **ADVANCES PAYABLE**

In the year ended December 31, 2023, three directors of the Company made advances in total of \$10,671 (2022 - \$28,000) to the Company to support its working capital that are interest free, unsecured, and due on demand. The outstanding balance was \$38,671 as of December 31, 2023 (2022 - \$28,000).

## **OFF-BALANCE SHEET ARRANGEMENTS**

The Company has no off-balance sheet arrangements.

#### **DISCLOSURE CONTROLS AND PROCEDURES**
