"Biosenta Inc. announces the approval of its "safe and powerful" disinfectant by the U.S. EPA"

Biosenta Inc. (**Biosenta**) **[(CSE:ZRO)]** is pleased to announce that its disinfectant, called "True" has been approved by the Environmental Protection Agency (EPA) in the U.S.A. Further, the EPA has allowed *True* to not carry a warning, caution or danger label because it is very safe for human use.

*True* is a new disinfectant and cleaner which effectively kills a multitude of potentially deadly microbes (bacteria, viruses and fungi/ mould) with a formulation that has been shown to be very safe for use. The innovation which gives *True* its unique properties is that it is both a very powerful disinfectant and it contains very low levels of active ingredients which make it much less toxic and more safe.

Mr. Dene Rogers, President and CEO of Biosenta said "*True* is a unique disinfectant that matches the best products on the market <u>and</u> it has the advantage of having a formulation that is very safe for use. Gaining EPA approval will allow Biosenta to begin to launch sales in the U.S., a market which is almost ten times the size of Canada."

Laboratory testing of *True* on a broad range of potentially deadly microbes has been conducted by a world renowned institution. These standardised tests have shown *True* will kill 100% of the following microbes within a 10 minute contact time:

Acinetobacter Baumannii (ABC) Adenovirus Black mould

E. Coli Chlamydia Trichophyton mentagrophytes

Approval to market and sell *True* in Canada is underway. The approval process in Canada was commenced in December, 2014 and approvals from Health Canada are expected in late-2015.

Biosenta Inc. develops and manufactures a range of chemical compounds for household and industrial applications using advanced nanotechnology.

Biosenta household disinfectants and cleaners possess similar levels of efficacy as traditional disinfectants but with significantly lower concentrations of active ingredients resulting in lower toxicity. These disinfectants and cleaners will kill 100% of potentially deadly mould, fungi, bacteria and viruses on contact and prevent re-growth. The disinfectants are very safe due to very low toxicity.

The industrial compounds are embedded to protect various materials, including drywall, plastics and resins, from microbe formation. These compounds remain active for decades and protect the drywalls of buildings, objects such as furniture, and carpet which contain plastic or resin, as well as textiles and paper from mould, fungi, bacteria and viruses.

Both the household and industrial products are environmentally safe and biodegradable.
