Biosenta Announces Ed Korhonen as Chairman and Am Gill as President and CEO

July 18, 2019 Toronto, Canada – Biosenta Inc. ("Biosenta" or the "Company") listed on the CNSX (CNSX: ZRO) announces its Board of Directors, on July 16, 2019, voted to approve the resignation of Dene Rogers as Chairman and CEO and appointed two members of the Board to assume his duties. Mr. Ed Korhonen, a board member since 2008, will serve as Chairman, and Mr. Am Gill, a board member since 2016, will become President and Chief Executive Officer of the Company effective immediately. Mr. Rogers will remain a Director of the Company.

Mr. Rogers has been Chairman since 2014 and has resigned to pursue a full-time position with another publicly-traded company. In reflecting on his tenure, he said, "it has been a pleasure to serve the shareholders of Biosenta and I look forward to remaining involved". Mr. Korhonen, the incoming Chairman added, "Under Dene's leadership, the Company has made substantial progress over the past four years by securing patents, validating the technical and manufacturing technology of Tri-Filler, and implementing the joint venture with its funding benefits. We are grateful to Dene for the results he delivered. I look forward to serving as Chairman and working with Am, Dene and my fellow Board members."

Mr. Gill said, "I am excited to work with members of the Board in the capacity of President and CEO. I thank Dene for all the contributions he has made to move the company forward. I am hoping that, with my background in financial markets and development, our commitment to research and development will become realized in the marketplace."
