(formally North Group Finance Limited) ("**Peekaboo**") dated September 26, 2016, whereby Peekaboo transferred 1,349,950 Shares and other assets to the Acquiror in exchange for settling debt in the aggregate amount of \$500,000 owed by Peekaboo to the Acquiror. The transaction did not take place on a market.

The Purchased Shares (as defined below) were acquired by 1022119 B.C. Ltd. (the "**Acquiror**")
