**INSTRUMENT OF PROXY FOR HOLDERS OF WARRANTS OF WEDGE ENERGY INTERNATIONAL INC.
FOR THE SPECIAL MEETING OF SECURITYHOLDERS

The undersigned holder (“**Wedge Warrantholder**”) of warrants (“**Wedge Warrants**”) of Wedge Energy International Inc. (the “**Corporation**”) hereby appoints Donald Padgett, the President and Director of the Corporation, or failing him, Sabino Di Paola, Chief Financial Officer of the Corporation, or instead of either of the foregoing, _____, as proxyholder of the undersigned, with full power of substitution, to attend and act and vote for and on behalf of the undersigned at the special meeting of Wedge Warrantholders and holders of common shares, stock options of the Corporation (collectively with the Wedge Warrants, the “**Wedge Securities**”) and holders of convertible notes (“**Wedge Noteholders**”) of the Corporation to be held on October 21, 2011 at 11:00 a.m. (the “**Meeting**”) and at any adjournment(s) thereof, and on every ballot that may take place in consequence thereof to the same extent and with the same powers as if the undersigned were personally present at the Meeting with authority to vote at the said proxyholders’ discretion, except as otherwise specified below.

Without limiting the general powers hereby conferred, the undersigned hereby directs the said proxyholder to vote the Wedge Warrants represented by this Instrument of Proxy in the following manner (**check the appropriate box**):

1. **FOR or AGAINST (and if no specification is made, FOR)** passing, with or without variation, a special resolution, the full text of which is set forth in Appendix B to the management information circular of the Corporation dated September 26, 2011 (the “**Information Circular**”), to approve the plan of arrangement pursuant to Section 288 of the *Business Corporations Act* (British Columbia), all as more particularly described in the Information Circular;
2. At the discretion of the said proxyholder, upon any amendment or variation of the above matters or any other matter that may properly be brought before the Meeting or any adjournment thereof, in such manner as such proxyholder, in his sole judgment may determine.

This Instrument of Proxy is solicited on behalf of the management of the Corporation. The Wedge Warrants represented by this Instrument of Proxy will be voted and, where the Wedge Warrantholder has specified a choice with respect to the above matters, will be voted as directed above or, if no direction is given, will be voted FOR the above matter. This Instrument of Proxy should be read in conjunction with the accompanying Information Circular.

Each Wedge Warrantholder has the right to appoint a proxyholder, other than the persons designated above, who need not be a Wedge Warrantholder, to attend and to act for and on behalf of such Wedge Warrantholder at the Meeting. To exercise such right, the names of the nominees of management should be crossed out and the name of the Wedge Warrantholder's appointee should be legibly printed in the blank space provided.
