Executive Summary

1

Micromine Consulting Services (MCS) was requested by the Novametal Resources LLC to submit a proposal for

- a) a competent persons NI 43-101 standard appraisal of the UT Project (Licence 8573X) in southern Mongolia and
- b) to provide planning and implementation of a geophysical program to help define drill targets. At this stage it is thought that an IP program represents the best method for generating drill targets.

The licence has outcrop available for inspection in addition to surface sampling results and other geochemistry results.

The total cost of the work program and estimated expenses is USD35,000 including expenses, and not including tax that may be an additional cost to the customer.

The program doesn't include the cost of external contractors such as geophysical companies nor does it include such things as assay costs.

2 Scope of Work

Novametal Resources LLC has requested MCS to provide the following services, should the work proposal be accepted -

- An MCS geologist will first travel to Ulaan Baatar and then the project site.
- An MCS geologist will visit the project site and will examine all outcroppings, the geological setting and will document all available data.
- Previous geochemical data will be entered into a database.
- Some surface confirmation samples will be taken and sent for analysis.
- The observed geology, geochemical data, and geological mapping will be used to compile a summary assessment of the OU Project.
- · The MCS geologist will write a competent persons report.
- The MCS geologist will plan and implement a geophysical program (IP) to help delineate anomalies that may constitute possible drill targets.

3 Preconditions

- All required data should be made available to the MCS geologist in a timely manner by Novametal Resources LLC.
- The site visit should be conducted at a time suitable for the MCS geologist to view outcrops and the geological situation.
- Novametal Resources LLC must be legally able to operate on the lease and in Mongolia.


