On March 29, 2018 the issuer issued 193,600,000 common shares at a deemed price of \$0.025 per common share in exchange for all of the issued and outstanding shares of DigiCrypts (the “**Transaction**”). The Acquiror completed the exchange of 22,000,000 DigiCrypts common shares for 22,000,000 TJR common shares pursuant to the Transaction.
