Pursuant to a private placement of the Issuer that closed on August 20, 2019, the Acquiror subscribed for and purchased 6,500,000 Common Shares at an aggregate subscription price of CAD\$650,000, or CAD\$0.10 per Common Share (the “**Financing**”).
