April 9, 2020 the Acquiror completed the last of a series of ordinary course sales of common shares (“**Common Shares**”) in the capital of the Issuer in the aggregate amount of 530,000 Common Shares through the facilities of the Exchange (collectively, the “**Transactions**”) to unknown and unrelated third-party purchasers for aggregate proceeds of CAD\$11,130, or approximately CAD\$0.021 per Common Share. As a result of the completion of the Transactions, the Acquiror owns 5,970,000 Common Shares.
