OVERVIEW

McLaren was incorporated on July 13, 1999 under the Business Corporations Act (Ontario). Since that time, the Company has predominantly been engaged in the acquisition, exploration and development of gold properties in Ontario. The Company is listed on the CSE under the symbol MCL, the OTC under MLRNF and on the FSE under 3ML. The address of the Company's corporate office and principal place of business is 44 Victoria St., Suite 1616, Toronto, ON., M5C 1Y2

Description of the Business

McLaren is a Canadian mineral exploration and development company, focused on gold exploration projects in northeastern Ontario. The Company recently completed a purchase and sale agreement ("PSA Agreement") and an option agreement ("Option Agreement") with Goldcorp Canada Ltd., a wholly-owned subsidiary of Newmont Corporation ("Newmont") on Newmont's McCool and Kerrs gold properties and McLaren's Augdome gold property, respectively. All three gold properties are located in the prolific Timmins Gold District in Northeastern Ontario where over 70 million ounces of gold have been produced to date.

On October 26, 2020, the Company acquired the remaining 50% interest of the past producing Blue Quartz Gold Mine property from its joint venture partner Orla Mining Ltd. ("Orla") to hold a 100% interest in the property. During the first fiscal quarter of 2021, the Company terminated an option agreement with TimGinn Exploration Limited. Both properties are located in the prolific Timmins Gold District in Northeastern Ontario.

Exploration and Evaluation Activities

Northern Ontario Canada

McCool Property

On May 14, 2020, McLaren acquired 100% interest in the 275 hectare ("ha") McCool gold property from Newmount Mining Corporation ("Newmount") subject to Newmont retaining a 1.0 % Net Smelter Royalty ("NSR") on future production. The 275 ha McCool gold property, held under one Ontario Mining Lease consisting of surface and mining rights, is located in McCool Township approximately 85 kilometres ("km") east of the City of Timmins. The property is situated along the Destor-Porcupine Deformation Zone between the Fenn-Gib and Jonpol gold deposits, approximately 18 km east of the producing Black Fox Gold Mine operated by McEwen Mining Inc. and approximately 22 km east-southeast of McLaren's Blue Quartz gold property, which hosts the former Blue Quartz Gold Mine.

On August 9, 2021 McLaren received a mineral exploration permit from the Ontario Ministry of Energy, Northern Development and Mines ("MENDM") which allows McLaren to undertake various surface exploration activities on its original McCool gold property including line cutting, geological and geophysical surveys and diamond drilling. McLaren intends to commence a first phase exploration program on the McCool gold property which

will consist of approximately 13 kilometres of line cutting and Induced Polarization geophysical surveys followed by the drilling of up to 10 holes. This program will be designed to further evaluate and trace the gold mineralization known to exist on the property along the Centre Hill Fault from the work of previous owners undertaken during the period 1982-1987.

On October 4, 2021, McLaren announced it had acquired an additional 50 full mineral claims and 10 partial mineral claims, together comprising approximately 1,375 ha, from two independent prospectors from the Timmins area. The new claims are contiguous with the original McCool gold property and bring the total size of the property to approximately 1,650 ha. The majority of the new claims cover the northwest strike extension of the Centre Hill Fault which is host to the known gold mineralization on the McCool property and which is interpreted to be a splay off of the major Destor-Porcupine Deformation Zone which is host to many gold deposits in the area. The expanded McCool gold property now covers an approximate five kilometre strike length of the gold-bearing Centre Hill Fault.

McLaren agreed to pay a total of \$30,000 in cash and issue 250,000 shares of McLaren to the vendors, in exchange for the transfer of the 60 new mineral claims to McLaren. The new mineral claims have been transferred to McLaren and McLaren has paid the \$30,000 in cash and issued the 250,000 shares of McLaren to the vendors.

On February 23, 2022, the Company announced the completion of phase one of its planned exploration program. Exsics Exploration Ltd. completed approximately 13 km of line-cutting and induced polarization ("IP") and ground magnetic ("GM") geophysical surveys. The first phase exploration program on a select portion of the Centre Hill Fault, a northwest trending fault structure which runs along the south side of the McCool Anticline and which is known to host significant gold mineralization on the McCool property. An initial interpretation of the results suggest the presence of several IP and GM anomalies along the Centre Hill Fault.

Kerrs Property

On May 14, 2020, McLaren acquired 100% interest in the 775 ha Kerrs gold property from Newmont subject to Newmont retaining a 1.0 % NSR on future production. The property is held under five Ontario Mining Leases consisting of surface and mining rights, is located in Kerrs Township. The property is located approximately 85 kilometres ("km") east of the City of Timmins and situated along the Destor-Porcupine Deformation Zone which is host to many of the gold deposits in the Timmins Gold District.

On June 30, 2021, McLaren announced it has been issued a mineral exploration permit by MENDM for its 100%-owned Kerrs gold property located in the prolific Timmins Gold District of Northeastern Ontario, Canada where over 70 million ounces of gold have been produced to date.

Northern Ontario Canada (continued)

Blue Quartz

On December 6, 2010, the Company and Orla Mining Ltd. ("Orla") (formerly Red Mile Minerals Corp.), entered into an Option Agreement whereby McLaren could earn a 50% interest in the Blue Quartz gold property, with the Company having the right of first refusal on the remaining 50% interest. The Property consists of 25 patented mining claims and is located in Beatty Township, Northern Ontario. To earn a 50% interest in the Blue Quartz Property, the Company paid \$10,000 cash and issued 100,000 common shares with a deemed price of \$0.14 per share and is required to spend \$200,000 on exploration and development.

On July 26, 2011, the Company purchased additional property "BQ-Extension" from 2285944 Ontario Limited consisting of 8 unpatented claims totaling 240 hectares or approximately 600 acres for a purchase price of \$68,000.

During the calendar period ended December 31, 2011, the Company completed the \$200,000 in exploration and development expenditures and exercised its option to acquire 50% of the Blue Quartz property holding 25 patented mining claims. A 1.0% Net Smelter Royalty ("NSR") is retained by the predecessor companies (Thundermin Resources Inc. and Wesdome Mines Ltd.). Upon completion of the earn in and exercising its option to acquire the 50% interest in the Blue Quartz property, the Company has the right to purchase 50% (.05%) of the NSR from the predecessor companies for \$250,000.

On September 26, 2011, the Company entered into an option agreement with Orla whereby Orla has the option to earn 50% interest in the Blue Quartz Property Extension ("BQ Extension") which is owned 100% by the Company. The BQ-Extension property consists of 8 unpatented claims totaling 240 hectares or approximately 600 acres. Upon completion of the option agreement the Company and Orla will each own 50% of the entire Blue Quartz and BQ-Extension Property package.

October 26, 2020, the Company acquired the remaining 50% interest of the Blue Quartz property, to hold a 100% interest, in the past producing Blue Quartz Gold Mine property located in the prolific Timmins Gold District of Northeastern Ontario. Consideration for the acquisition was 300,000 treasury shares of McLaren which cannot be traded on the open market by Orla prior to October 15, 2021.

Augdome

McLaren controls a 100% interest in the 414 ha Augdome Gold Property located in Tisdale and Whitney Townships in the prolific Timmins Gold District, Northeastern Ontario. The Property is located immediately east of the Dome Mine operated by Newmont.

On May 14, 2020, McLaren entered into an option agreement with Newmont. McLaren has granted Newmont an option to acquire a 100% interest in McLaren's 408 ha Augdome gold property, subject to McLaren retaining a 1.0% NSR on any future production from the Augdome property. The option can be exercised by Newmont at any time prior to May 5, 2024 upon the payment by Newmont of CDN \$500,000 to McLaren, such amount to be

increased on a yearly basis according to the Canadian Consumer Price Index commencing on January 1, 2021 until the option is exercised.

TimGinn

On January 6, 2021,, McLaren terminated its option agreement with TimGinn Exploration Limited effective December 31, 2020.

OBJECTIVES AND MILESTONES

McLaren is a Canadian mineral exploration and development company focused on gold exploration projects in Northeastern Ontario. McLaren recently completed a purchase and sale agreement ("PSA Agreement") and an option agreement ("Option Agreement") with Goldcorp Canada Ltd., a wholly-owned subsidiary of Newmont Corporation ("Newmont"), on Newmont's McCool and Kerrs gold properties and McLaren's Augdome gold property, respectively. The Company intends to provide more technical information on these properties and its exploration plans once its technical team has had an opportunity to more thoroughly review the available exploration data provided by Newmont and government archives.

FINANCING

On December 31, 2021 the Company closed a non-brokered private placement financing consisting of 3,808,000 flow-through share units (the "Flow-Through Units") issued at a price of \$0.07 per unit for gross proceeds of \$266,560. Each Flow-Through Unit consisted of one common share in the capital of McLaren issued on a flow-through basis pursuant to the Income Tax Act (Canada) and one-half of one common share purchase warrant. Each whole warrant is exercisable at a price of \$0.10 per common share for a period of 24 months from the date of issuance.

On December 31, 2020 the Company closed a non-brokered private placement financing consisting of 3,750,000 flow-through share units (the "Flow-Through Units") issued at a price of \$0.08 per unit for gross proceeds of \$300,000. Each Flow-Through Unit consisted of one common share in the capital of McLaren issued on a flow-through basis pursuant to the Income Tax Act (Canada) and one-half of one common share purchase warrant. Each whole warrant is exercisable at a price of \$0.125 per common share for a period of 18 months from the date of issuance.

Gross proceeds from the financing will be used by McLaren for exploration expenditures on its McCool, Blue Quartz and Kerrs gold properties located in the prolific Timmins Gold District in Northern Ontario.

On July 13, 2020, McLaren closed a non-brokered private placement financing consisting of 5,200,000 flow-through share units (the "Flow-Through Units") and 6,540,000 common share units (the "Common Share Units") for aggregate gross proceeds of \$587,000.

FINANCING (continued)

Both the Flow-Through Units and the Common Share Units were issued at a price of \$0.05 per unit. Each Flow-Through Unit consists of one common share in the capital of McLaren issued on a flowthrough basis pursuant to the Income Tax Act (Canada) and one-half of one common share purchase warrant. Each Common Share Unit consists of one common share in the capital of McLaren and one common share purchase warrant. Each whole warrant is exercisable at a price of \$0.10 per common share for a period of 18 months from the date of issuance.

As the Flow-through shares were not issued at a premium to the closing market price, a Flow-through share premium was not recorded. In connection with the financing, McLaren paid finder's fees consisting of \$21,875 in cash, including a finder's fee of \$1,750 to Accilent Capital Management Inc.

On December 31, 2019, the Company issued 600,000 Flow-through common share units at \$0.05 per share for gross proceeds of \$30,000. Each Flow-through unit consists of one Flow-through common share and one half (1/2) common share purchase warrant. Each whole warrant is exercisable at \$0.10 for a period of 18 months from the date of issuance. The Company shall have the right to accelerate the exercise of the warrants if the Company's shares trade at a weighted average price exceeding \$0.15 per share for 20 consecutive trading days. In connection with the financing, the Company paid a finder's fees consisting of \$2,100 in cash and also issued 42,000 Broker warrants with an exercise price of \$0.10 per share for a period of 18 months from the date of issuance. The Flow-through warrants were valued at \$1,077 and the Broker warrants were valued at \$151 using the Black-Scholes valuation model.

As the Flow-through shares were issued at a premium to the closing market price, a Flow-through share premium of \$15,000 was recorded.

Gross proceeds from the Flow-Through Units will be used by McLaren for exploration expenditures on its gold properties located in the Timmins Gold District in Northern Ontario. Net proceeds from the Common Share Units will be used for general corporate purposes.

Stock Options

During the quarter 1,525,000 stock options were issued and 1,225,000 stock options expired. The number of Stock Options outstanding at June 30, 2022 is 3,700,000.

OVERALL PERFORMANCE

Over the last several years, the global financial and commodity markets continued to be characterized by volatility as market participants reacted and responded to uncertainty over the North American and international economies. These circumstances have had an impact on the Company's operations and, in particular, on the economics of its existing exploration and development projects, its strategy to evaluate and, if attractive, complete potential acquisitions and otherwise its ability to pursue growth opportunities.

OPERATIONAL REVIEW & RESULTS OF OPERATIONS

FOR THE THREE MONTHS ENDED JUNE 30, 2022

Net loss for the three months ended June 30, 2022 of \$(71,272) (June 30, 2021 - \$(68,644)). Compared to the three month period ending June 30, 2021. Overall, Office and general expenses increased \$2,461 from the 2021 three month period, with a decrease in Professional fees offset by increases in Investor relations and insurance.

Exploration and evaluation expense remained consistent as the Company's work permits were delayed until after the quarter end.

FINANCING

On December 31, 2021, the Company issued 3,808,000 Flow-through common share units at \$0.07 per share for gross proceeds of \$266,560. Each unit consists of one Flow-through common share and one half (1/2) common share purchase warrant, exercisable at \$0.10 for a period of 24 months. The common share purchase warrants were valued at \$26,562 using the Black Scholes valuation model. A finder fee of \$2,205 was paid in cash and 266,000 shares issued relating to the financing.

On December 31, 2020, the Company issued 3,750,000 Flow-through common share units at \$0.08 per share for gross proceeds of \$300,000. Each unit consists of one Flow-through common share and one half (1/2) common share purchase warrant, exercisable at \$0.125 for a period of 18 months. The common share purchase warrants were valued at \$51,288 using the Black Scholes valuation model. A finder fee of \$19,740 was paid in cash.

On July 13, 2020, McLaren closed a non-brokered private placement financing consisting of 5,200,000 flow-through share units (the "Flow-Through Units") and 6,540,000 common share units (the "Common Share Units") for aggregate gross proceeds of \$587,000.

LIQUIDITY

Operating Activities

Cash flow used in operating activities during the three months ended was \$65,612 and \$231,429 for the nine month period June 30, 2022 spent on operating, administrative and exploration and evaluation expenses during the year.

Liquidity Outlook

As at this report date, August 17, 2022, the Company has \$324,780 in cash. At September 30, 2021 the Company had cash of \$441,100 available, an decrease of \$116,320.

As at June 30, 2022, the Company had a working capital surplus of \$404,106, excluding the \$71,874 non-cash Flow through premium liability, a decrease of \$18,380 from the working capital balance surplus of \$422,486 at September 30, 2021.

Notwithstanding the success to date in acquiring equity financing on acceptable terms, there is no guarantee of obtaining future equity financings or on what terms any such equity capital may be available to the Company and, as such, alternative funding programs are also being pursued by the Company.

The Company must utilize its current cash reserves, funds obtained from the exercise of options and warrants, if any, and other financing transactions to maintain the Company's capacity to meet working capital requirements, ongoing discretionary and committed exploration programs. The Company anticipates that it will raise additional capital when and if the opportunity arises. See "Risk Factors".

On the date of this MD&A, the cash resources of the Company, \$376,493 are held in cash with a major Canadian financial institution. Amount receivable is comprised of harmonized sales tax receivables from the Government of Canada.

OFF STATEMENT OF FINANCIAL POSITION TRANSACTIONS

During the three months ended June 30, 2022, there were no off statement financial position transactions. The Company has not entered into any specialized financial agreements to minimize its investment risk, currency risk or commodity risk.

PROPOSED TRANSACTIONS

On November 30th, 2021, the Company announced commencement of its Phase One exploration program on its 100% owned McCool gold property located in the prolific Timmins Gold Region of Northwestern Ontario, Canada.

On February 23, 2022, the Company announced the completion of phase one of its planned exploration program. Exsics Exploration Ltd. completed approximately 13 km of line-cutting and induced polarization ("IP") and ground magnetic ("GM") geophysical surveys. The first phase exploration program on a select portion of the Centre Hill Fault, a northwest trending fault structure which runs along the south side of the McCool Anticline and which is known to host significant gold mineralization on the McCool property. An initial interpretation of the results suggests the presence of several IP and GM anomalies along the Centre Hill Fault. (see news release dated February 23, 2022 which contains maps showing the favourable geologic structures on the McCool Property along with a table of Selected Historical Drill Results).

The Company has been actively evaluating proposals from several drilling companies for the upcoming drill program in Q4 of fiscal 2022.

DIVIDENDS

The Company has neither declared nor paid any dividends on its common shares. The Company intends to retain its earnings, if any, to finance growth and expand its operations and does not anticipate paying any dividends on its common shares in the foreseeable future.

As at June 30, 2022 under the Flow-through share issuance as described under notes 12(b)(ii) note 12(b)(vi) and note 12(b)(ix) to the June 30, 2022 financial statements, the Company is obligated to incur \$709,957 of eligible Canadian exploration expenditures for renunciation to the flow-through shares subscribers by December 31, 2022.

The Government of Canada has extended the deadline to complete the necessary spending requirements from the issuance of flow-through shares raised in 2020 by one year. The Company will have until December 31, 2022 to spend these amounts.

OTHER

Since March 2020, the outbreak of the novel strain of coronavirus (COVID-19) and its variants, has continued to result in governments worldwide, enacting emergency measures to combat the spread of the virus. These measures, which include the implementation of travel bans, self-imposed quarantine periods and social distancing, have caused material disruption to businesses globally resulting in an economic slowdown. Global equity markets have experienced significant volatility and weakness. Governments and central banks have reacted with significant monetary and fiscal interventions designed to stabilize economic conditions. The duration and impact of the COVID-19 outbreak is unknown at this time, as is the efficacy of the government and central bank interventions. It is not possible to reliably estimate the length and severity of these developments and the impact on the financial results and condition of the Company in future periods. The Government of Ontario allows mining activity to continue pursuant to regulations related to Covid-19 and therefore the Company continues to plan and carry out exploration activities.

The Company and its operations have been largely unaffected by the impact of the COVID-19 global pandemic and continues to follow all related government measures, mandates and recommendations from health officials. The Company continues to believe that it will remain largely unaffected, however the future impact on the Company, if any, is uncertain at this time.

The Company's financial instruments comprise cash, marketable securities, accounts receivable and accounts payable and accrued liabilities.

As at June 30, 2022, the carrying and fair value amounts of the Company's financial instruments are approximately equivalent.

Financial Instrument Risk Exposures

It is management's opinion that the Company is not exposed to significant interest or credit risks arising from its financial instruments and that their fair values approximate their carrying value unless otherwise noted. Fluctuation in currency exchange rates, have no material impact on the Company's earnings and cash flows.

Risks and Uncertainties

Political Risk

All of the Company's mineral properties are located in Canada. Accordingly, the Company is subject to risks normally associated with exploration for and development of mineral properties in this country. The Company's mineral exploration activities could be affected in varying degrees by political instability, aboriginal land claims and government regulation relating to the mining business. Operations may also be affected in varying degrees by terrorism, military conflict or repression, crime, extreme fluctuations in currency rates and high inflation.

Interest Rate Risk

The Company invests cash surplus to its operational needs in investment-grade short term deposits certificates issued by the bank where it keeps its Canadian bank accounts. The Company periodically assesses the quality of its investments with this bank and is satisfied with the credit rating of the bank and the investment grade of its short-term deposit certificates.

Equity Price Risk

Market risk arises from the possibility that changes in market prices will affect the value of the financial instruments of the Company. The Company is exposed to fair value fluctuations on its investments. The Company's other financial instruments (cash and cash equivalents, amounts receivable, accounts payable and accrued liabilities) are not subject to price risk.

Liquidity Risk

The Company's approach to managing liquidity risk is to ensure that it will have sufficient liquidity to meet liabilities when due. As at June 30, 2022, the Company had current assets of \$422,514 (September 30, 2021 - \$456,290) and current liabilities of \$18,408, exclusive of the non-cash flow-through liability of \$71,874 (September 30, 2021 - \$33,804). All of the Company's financial liabilities and receivables are subject to normal trade terms. The Company had a current working capital surplus, as at December 31, 2021, of \$404,106, exclusive of the non-cash flow-through premium liability of \$71,874 (September 30, 2021 - \$422,486).

Business Risk

There are numerous business risks involved in the mineral exploration industry, some of which are outlined below. The Company may not always own 100% of the mineral claims, concessions, rights or other interests. Similarly, any non-compliance with or non-satisfaction of the terms of an option agreement by the Company could affect its ability to exercise the option and earn its interest in the claims, concessions and assets relating to mineral properties. Mining claims, concessions or other interests may not include surface rights and there can be no assurance that the Company will be successful in negotiating long-term surface rights access agreements in respect of the properties. Failure to obtain surface rights could have an adverse impact on the Company's future operations.

The Company's current or future operations, including development activities, are subject to environmental regulations which may make operations not economically viable or prohibit them altogether. The success of the operations and activities of the Company is dependent to a significant extent on the efforts and abilities of its management, outside contractors, experts and other advisors. Investors must be willing to rely to a significant degree on management's discretion and judgment, as well as the expertise and competence of the outside contractors, experts and other advisors. The Company does not have a formal program in place for succession of management and training of management. The loss of one or more of the key employees or contractors, if not replaced on a timely basis, could adversely affect the Company's operations and financial performance.

Foreign Currency Risk

The Company's exploration and evaluation activities are substantially denominated in Canadian dollars. The Company's funds are kept in Canadian dollars, with a major Canadian financial institution.

Commodity Price Risk

The price of the common shares in the capital the Company, its financial results, exploration and evaluation activities have been, or may in the future be, adversely affected by declines in the price of gold and/or other metals. Gold prices fluctuate widely and are affected by numerous factors beyond the Company's control, such as the sale or purchase of commodities by various central banks, financial institutions, expectations of inflation or deflation, currency exchange fluctuations, interest rates, global or regional consumptive patterns, international supply and demand, speculative activities and increased production due to new mine developments, improved mining and production methods and international economic and political trends. The Company's revenues, if any, are expected to be in large part derived from mining and sale of precious and base metals or interests in properties related thereto. The effect of these factors on the price of precious and base metals, and therefore the economic viability of any of the Company's exploration projects, cannot accurately be predicted.

Environmental and Permitting

All aspects of the Company's operations are subject to environmental regulation in the various jurisdictions in which it operates. These regulations, among other things, mandate the maintenance of air and water quality standards, land reclamation, transportation, storage and disposal of hazardous waste. Environmental legislation is evolving in a manner which will require stricter standards and enforcement, increased fines and penalties for non-compliance, more stringent environmental assessments of proposed projects and a heightened degree of responsibility for companies and their officers, directors, and employees. There is no assurance that future changes in environmental regulation, if any, will not adversely affect the Company's operations.

Additional Capital

The exploration activities of the Company may require substantial additional financing. Failure to obtain sufficient financing may result in delaying or indefinite postponement of exploration and development of any of the Company's properties. There can be no assurance that additional capital or other types of financing will be available if needed or that, if available, the terms of such financings will be favourable to the Company. In addition, low commodity prices may affect the Company's ability to obtain financing.

Acquisition

The Company uses its best judgment to acquire mining properties for exploration and development. In pursuit of such opportunities, the Company may fail to select appropriate acquisition candidates or negotiate acceptable agreements, including arrangements to finance the acquisitions and development, or integrate such opportunity and their personnel with the Company. The Company cannot assure that it can complete any acquisition that it pursues or is currently pursuing, on favourable terms, or that any acquisition completed will ultimately benefit the Company.

Segregation of duties

Segregation of duties is a basic, key internal control and one of the most difficult to achieve in a small company. It is used to ensure that errors or irregularities are prevented or detected on a timely basis by employees in the normal course of business. Due to the Company's small size and limited resources, a complete segregation of duties within the Company's accounting group cannot be fully achieved. The result is that the Company is highly reliant on the performance of mitigating procedures during the process of closing its financial statements in order to ensure the financial statements are presented fairly in all material respects. Management will identify and hire additional accounting resources where cost effective and when required. Where it is not cost effective to obtain additional accounting resources, management will review existing mitigating controls and, if appropriate, implement changes to its internal control processes whereby more effective mitigating controls will be adopted.

Competition

The mining industry is intensely competitive in all of its phases, and the Company competes with many companies possessing greater financial resources and technical facilities than the Company. Competition in the mining business could adversely affect the Company's ability to acquire suitable producing properties or prospectus for mineral exploration in the future.

Reliance on Management

The success of the Company depends to a large extent upon its abilities to retain the services of its senior management and key personnel. The loss of the services of any of these persons could have a materially adverse effect on the Company's business and prospects. There is no assurance the Company can maintain the services of its directors, officers or other qualified personnel required to operate its business. Internal controls over financial reporting are procedures designed to provide reasonable assurance that transactions are properly authorized, assets are safeguarded against unauthorized or improper use, and transactions are properly recorded and reported. A control system, no matter how well designed and operated, can provide only reasonable, not absolute, assurance with respect to the reliability of financial reporting and financial statement preparation.
