On August 1, 2017, Golden Predator acquired ownership of 4,500,000 common shares of the Issuer pursuant to a property option agreement (the “**Agreement**”).

On August 1, 2017, Golden Predator acquired ownership of 4,500,000 common shares of the Issuer pursuant to the Agreement.

Prior to the foregoing acquisition, Golden Predator owned 5,250,000 common shares of the Issuer representing approximately 14.98% of the issued and outstanding common shares of the Issuer, and 1,750,000 warrants of the Issuer. As a result of the foregoing acquisition, Golden Predator owns an aggregate of 9,750,000 common shares of the Issuer representing approximately 24.65% of the issued and outstanding common shares of the Issuer. Golden Predator would own 11,500,000 common shares of the Issuer, representing approximately 27.85% of the issued and outstanding common shares of the Issuer on a partially diluted basis, assuming the exercise of 1,750,000 warrants and that no further common shares of the Issuer have been issued.

Golden Predator would own 11,500,000 common shares of the Issuer, representing approximately 27.85% of the issued and outstanding common shares of the Issuer on a partially diluted basis, assuming the exercise of 1,750,000 warrants and that no further common shares of the Issuer have been issued.

(b) the acquiror, either alone or together with any joint actors, has ownership but control is held by persons or companies other than the acquiror or any joint actor, and

Pursuant the Agreement, Golden Predator was issued the foregoing securities at a deemed transaction price of \$0.20 per share (based on the July 31, 2017 closing price on the TSX Venture Exchange) representing an aggregate value of \$900,000 for the option to acquire mineral properties.

Pursuant the Agreement, Golden Predator was issued the foregoing securities at a deemed transaction price of \$0.20 per share representing an aggregate value of \$900,000 for the option to acquire mineral properties.
