

NOTICE OF CHANGE IN CORPORATE STRUCTURE

Pursuant to Section 4.9 of National Instrument 51-102 Continuous Disclosure Obligations

Item 1 Names of the Parties to the Transaction

The following entities were parties to the transaction:

- (i) Fox-Tek Canada Inc. (“**Fox-Tek**”), a private company incorporated under the laws of the Province of Ontario
- (ii) Sensor Technologies Corp. (formerly Mooncor Oil & Gas Corp.) (the “**Corporation**”), a public company incorporated under the laws of the Province of Ontario

Item 2 Description of the Transaction

On October 24, 2018, the Corporation completed its acquisition (the “**Acquisition**”) of all of the issued and outstanding securities of Fox-Tek, as further described in the Corporation’s information circular dated June 29, 2018. Immediately after the closing of the Acquisition, Fox-Tek became a direct, wholly-owned subsidiary of the Corporation and the sole shareholder of Fox-Tek, IntellaEquity Inc., exercises control over the Corporation.

The Acquisition was completed by way of a three corner amalgamation (the “**Amalgamation**”) among the Corporation, its wholly-owned subsidiary, Sensor Technologies Inc. (“Subco”) and Fox-Tek. The Amalgamation agreement was entered into among the Corporation, Fox-Tek and Subco on June 11, 2018 (the “**Agreement**”). Pursuant to the Agreement, Fox-Tek and Subco amalgamated pursuant to the *Business Corporations Act* (Ontario) and pursuant to the Amalgamation, which closed on October 23, 2018, the Corporation acquired all of the securities of Fox-Tek in exchange for the issuance of 47,500,000 Corporation common shares at a deemed value of \$0.20 per common share, for aggregate consideration of \$21,721,893.

The common shares of the Corporation commenced trading on through the facilities of the Canada Securities Exchange under the symbol “SENS” at the open of markets on October 24, 2018.

Item 3 Effective Date of the Transactions

The effective date of the Acquisition is October 23, 2018.

Item 4 Name of Each Party, if any, that Ceased to be a Reporting Issuer Subsequent to the Transaction and of each Continuing Entity

The Corporation is the continuing entity and is a reporting issuer in the provinces of Ontario, British Columbia and Alberta.

Fox-Tek is a direct, wholly-owned subsidiary of the Corporation and the holder of the Fox-Tek common shares exercises control of the Corporation.

Item 5 Date of the Reporting Issuer’s First Financial Year-End Subsequent to the Transaction

The first financial year-end of the Corporation, subsequent to the Acquisition, is December 31, 2018.

Item 6 Periods, Including Comparative Periods, if any, of the Interim and Annual Financial Statements Required to be Filed for the Company’s First Financial Year Subsequent to the Transaction

Effective the date of the completion of the Acquisition, the Corporation has adopted the financial year end of December 31, 2018.
