

# PLATINEX GRANTS ADDITIONAL OPTIONS

Toronto, Ontario, January 5, 2011 – Platinex Inc. (TSX-V: PTX), announced today that the company has approved granting an additional 170,000 options to Investor Cubed Inc. ("ICI") as part of an expanded Investor Relations program.
