On June 28, 2016 and August 25, 2016, of 700,000 Units and 400,000 Units, respectively, of the Issuer at a price of \$0.025 per Unit.

On June 28, 2016 the Acquiror acquired 700,000 units ("Units") of the Issuer at a price of \$0.025 per Unit. Each Unit consists of one common share and one common share purchase warrant (a "Warrant"). Each Warrant entitles the holder thereof to acquire one common share at a price of \$0.05 per common share on or before June 28, 2017, and thereafter at an exercise price of \$0.10 on or before June 28, 2021.

On August 25, 2016 the Acquiror acquired 400,000 units ("Units") of the Issuer at a price of \$0.025 per Unit. Each Unit consists of one common share and one common share purchase warrant (a "Warrant"). Each Warrant entitles the holder thereof to acquire one common share at a price of \$0.05 per common share of the warrant is exercised on or before June 28, 2017 and thereafter upon payment of an exercise price of \$0.10 on or before June 28, 2021.

The Units were issued pursuant to a subscription agreement entered into between the Issuer and the Acquiror as part of a larger private placement of the Issuer's securities.

As a result of the acquisitions of Units, the Acquiror currently owns 7,350,760 common shares, 1,100,000 common share purchase warrants representing 11.3% of the total issued common shares on an undiluted basis and 10.8% assuming the Warrants held by the Acquiror are exercised.

- 3.2 State whether the acquiror acquired or disposed ownership of, or acquired or ceased to have control over, the securities that triggered the requirement to file this report.**

The Acquiror acquired ownership of 700,000 Units and 400,000 Units of the Issuer, on June 28, 2016 and August 25, 2016, respectively, of at a price of \$0.025 per Unit.

The Acquiror held 6,250,760 common shares prior to the private placement transactions. Following the acquisition of common shares on June 28, 2016 and August 25, 2016, the Acquiror owns 7,350,760 common shares and 1,100,000 Warrants, representing 11.3% of the total issued common shares of the Issuer on an undiluted basis and 10.8% assuming the Warrants held by the Acquiror are exercised.
