On September 20, 2021, the Company completed the acquisition of all of the issued and outstanding shares of Blender Bites (Holdings) Limited (formerly: Blender Bites Incorporated) (the "RTO Acquiror") pursuant to a definitive share purchase agreement dated August 31, 2021 (the "Transaction") and the RTO Acquiror became a wholly-owned subsidiary of the Company.
