The following management discussion and analysis (“MD&A”) should be read in conjunction with the CellStop Systems Inc.’s (the “Company”) unaudited condensed consolidated interim financial statements for the period ended May 31, 2014 and 2013 and the notes thereto.

The unaudited condensed financial statements and comparative information have been prepared by management in accordance with International Financial Reporting Standard (“IFRS”), as issued by the International Accounting Standards Board (“IAS”). The Company’s accounting policies and estimates used in the preparation of these interim financial statements are considered appropriate in the circumstances, but are subject to judgments and uncertainties inherent in the financial reporting process. This analysis contains forward-looking statements about the Company’s future prospects that involve certain risks and uncertainties and the Company provides no assurances that actual results will meet management’s expectations. This document is current in all material respects as of June 26, 2014.

Management is responsible for the preparation and integrity of the unaudited condensed consolidated interim financial statements, including the maintenance of appropriate information systems, procedures and internal controls to ensure that information used internally or disclosed externally, including the consolidated financial statements and MD&A, is complete and reliable.

NATURE OF OPERATIONS

The Company is presently analyzing various opportunities to invest its capital. Previously the Company was in the business of providing wireless telemetry solutions utilizing the GSM network. On September 01, 2007, the Company ceased its operations, being the development and marketing of automotive security using wireless GSM technology, upon the sale of its subsidiary, CellStop International Limited.

OVERVIEW

The Company is a public company incorporated under the laws of British Columbia. The Company is a reporting issuer in Alberta, British Columbia, Saskatchewan, Manitoba and Ontario and its shares are now listed and quoted for trading on the NEX under the trading symbol KNO.H.

RESULTS OF OPERATIONS

Third quarter – Three months period ended May 31, 2014, compared to three month period ended May 31, 2013.

Revenue, Cost of Sales and Gross profit

The Company does not have any active operations other than analyzing investments in which to invest its capital. Therefore no revenue was recorded during the period ended May 31, 2014 and 2013.

General and Administration

General and administration expenses from operations of \$34,735 has increased by 11% for the quarter ended May 31, 2014, compared to general and administration expenses of \$31,291 in the prior year. The increase in general and administration expenses compared to prior year is the due to a increase in operational costs.

Salaries, Wages and Consulting fees

Salaries, wages and consulting fees from operations of \$6,000 for the quarter ended May 31, 2014, compared to salaries, wages and consulting fees from continuing operations of \$6,000 in the prior year.

1st quarter ended November 30, 2011

The net loss of \$35,955 has decreased for the quarter ended November 30, 2011, compared to net loss of \$38,816 in the first quarter of fiscal 2011 and an increase compared to net loss of \$33,323 for the fourth quarter of 2011. The decrease in net loss compared to the net loss for the first quarter of fiscal 2011 is due interest expense incurred during the quarter ended November 30, 2010. The increase in net loss compared to the net loss for the fourth quarter of fiscal 2011 is due to higher operational expenses.

2nd quarter ended February 29, 2012

The net loss of \$44,784 has increased for the quarter ended February 29, 2012, compared to net loss of \$19,084 in the second quarter of fiscal 2011 and increased compared to net loss of \$35,955 for the first quarter of fiscal 2012. The increase in net loss compared to the net loss for the second quarter of fiscal 2011 is due an increase in operational expenses and additional consulting costs incurred.

3rd quarter ended May 31, 2012

The net loss of \$36,347 has increased for the quarter ended May 31, 2012, compared to net loss of \$18,062 in the third quarter of fiscal 2011 and decreased compared to net loss of \$44,784 for the second quarter of fiscal 2012. The increase in net loss compared to the net loss for the third quarter of fiscal 2011 is due an increase in operational expenses incurred.

4th quarter ended August 31, 2012

The net loss of \$6,216 has decreased for the quarter ended August 31, 2012, compared to net loss of \$33,323 in the fourth quarter of fiscal 2011 and decreased compared to net loss of \$36,347 for the third quarter of fiscal 2012. The decrease in net loss compared to the net loss for the fourth quarter of fiscal 2011 is due the extinguishment of long outstanding payables.

1st quarter ended November 30, 2012

The net loss of \$35,043 has decreased for the quarter ended November 30, 2012, compared to net loss of \$35,955 in the first quarter of fiscal 2012 and an increase compared to net loss of \$6,216 for the fourth quarter of 2012. The decrease in net loss compared to the net loss for the first quarter of fiscal 2012 is due a decrease in operational costs incurred during the quarter ended November 30, 2012. The increase in net loss compared to the net loss for the fourth quarter of fiscal 2012 is due the extinguishment of long outstanding payables in the fourth quarter of fiscal 2012.

2nd quarter ended February 28, 2013

The net loss of \$39,946 has decreased for the quarter ended February 28, 2013, compared to net loss of \$44,784 in the second quarter of fiscal 2012 and an increase compared to net loss of \$35,043 for the first quarter of 2013. The decrease in net loss compared to the net loss for the second quarter of fiscal 2012 is due a decrease in operational costs incurred during the quarter ended February 28, 2013. The increase in net loss compared to the net loss for the first quarter of fiscal 2013 is due to an increase in operational costs.

3rd quarter ended May 31, 2013

The net loss of \$37,291 has increased for the quarter ended May 31, 2013, compared to net loss of \$36,347 in the third quarter of fiscal 2012 and a decrease compared to net loss of \$39,946 for the second quarter of 2013. The increase in net loss compared to the net loss for the third quarter of fiscal 2012 is due an increase in operational costs incurred during the quarter ended May 31, 2013. The decrease in net loss compared to the net loss for the second quarter of fiscal 2013 is due to a decrease in operational costs.

4th quarter ended August 31, 2013

The net loss of \$30,574 has increased for the quarter ended August 31, 2013, compared to net loss of \$6,216 in the fourth quarter of fiscal 2012 and a decrease compared to net loss of \$37,291 for the third quarter of 2013. The increase in net loss compared to the net loss for the fourth quarter of fiscal 2012 is due an increase in operational costs incurred during the quarter ended August 31, 2013. The decrease from the third quarter of fiscal 2013 is due to a decrease in accrued fees.

1st quarter ended November 30, 2013

The net loss of \$34,765 has decreased for the quarter ended November 30, 2013, compared to net loss of \$35,043 in the first quarter of fiscal 2013 and an increase in net loss compared to net loss of \$30,574 for the fourth quarter of 2013. The decrease in net loss compared to the net loss for the first quarter of fiscal 2013 is due a decrease in operational costs incurred during the quarter ended November 30, 2013. The increase in net loss compared to the net loss for the fourth quarter of fiscal 2013 is due to a decrease in accrued fees in the fourth quarter of fiscal 2013.

2nd quarter ended February 28, 2014

The net loss of \$38,360 has decreased for the quarter ended February 28, 2014, compared to net loss of \$39,946 in the second quarter of fiscal 2013 and an increase in net loss compared to net loss of \$34,765 for the first quarter of 2014. The decrease in net loss compared to the net loss for the second quarter of fiscal 2013 is due a decrease in operational costs incurred during the quarter ended February 28, 2014. The increase in net loss compared to the net loss for the first quarter of fiscal 2014 is due to an increase in public company operational expenses in the second quarter of fiscal 2014.

3rd quarter ended May 31, 2014

The net loss of \$40,735 has increased for the quarter ended May 31, 2014, compared to net loss of \$37,291 in the third quarter of fiscal 2013 and an increase compared to net loss of \$38,360 for the second quarter of

2014. The increase in net loss compared to the net loss for the third quarter of fiscal 2013 and the second quarter of fiscal 2014 is due an increase in operational costs incurred during the quarter ended May 31, 2014.

LIQUIDITY AND CAPITAL RESOURCES

The Company does not currently have an adequate source of reliable, long-term revenue to fund operations. As a result, the Company is reliant on outside sources of funding. There can be no assurances that the Company will in the future achieve a consistent and reliable revenue stream adequate to support continued operations in the future. In addition, there are no assurances that the Company will be able to secure adequate sources of new capital, whether it be in the form of capital, debt, or other financing sources.

The future cash requirements of the Company will be dependant on the Company's success in identifying an acquisition or otherwise establishing or renewing operations. The Company's ability to develop and maintain a new financially viable business plan is uncertain.

During the quarter ended May 31, 2014, the Company obtained a \$10,000 unsecured loan, which expires on April 28, 2015. The interest rate is 10% per annum payable quarterly.

Working capital deficit on May 31, 2014, was (\$49,345) compared to working capital of \$64,515 as at August 31, 2013. The decrease in working capital was due to operational expenses which were incurred in fiscal 2014.

In the period ended May 31, 2014, the Company generated negative cash outflow of \$9,414 compared to negative cash outflow of \$28,238 in the prior year. This decrease in negative cash flow is as a result of an decrease in operational expenses.

1. Effective August 1, 2012, the Company entered into an office rental agreement of \$5,500 per month with an arm's length party. The agreement expires on July 31, 2015.

OFF-BALANCE SHEET ARRANGEMENTS

There are no off-balance sheet arrangements.

RELATED PARTY TRANSACTIONS

The value of transactions and outstanding balances relating to key management personnel were as follows:

- a) The Company paid \$6,000 (May 31, 2013 – \$6,000) to an officer of the Company for management services provided (Note 7(b)), of which \$4,000 (May 31, 2013 – \$2,000) remained outstanding in accounts payable and accrued liabilities as at May 31, 2014.
- b) The Company paid \$5,913 (May 31, 2013 – \$143) to a director of the company for legal services provided of which \$5,913 (May 31, 2013 – \$143) remained outstanding in accounts payable as at May 31, 2014.

PROPOSED TRANSACTIONS

The Company continues to seek to strengthen its board of directors and management, to find new business opportunities, and to raise capital.

SUBSEQUENT EVENTS

There are no subsequent events.

CRITICAL ACCOUNTING ESTIMATES

The Company has no active operations at this time other than analyzing various opportunities in which to invest its capital. Therefore currently the Company does not have any critical accounting estimates.

RECENT ACCOUNTING PRONOUNCEMENTS

Standards issued but not yet effective up to the date of issuance of the Company's consolidated financial statements are listed below. This listing is of standards and interpretations issued, which the Company reasonably expects to be applicable at a future date. The Company intends to adopt these standards when they become effective. The following pronouncements are being assessed to determine their impact on the Company's results and financial position:

(a) IFRS 9, Financial Instruments - Classification and Measurement ("IFRS 9"):

IFRS 9 – Financial Instruments is intended to replace IAS 39 - Financial Instruments: Recognition and Measurement (“IAS 39”) in three main phases. IFRS 9 will be the new standard for the financial reporting of financial instruments, and is effective for annual periods beginning on or after January 1, 2015, with earlier adoption permitted. In November 2009 and October 2010, IFRS 9 (2009) and IFRS 9 (2010) were issued, respectively, which address the classification and measurement of financial assets and financial liabilities. IFRS 9 (2009) requires that all financial assets be classified as subsequently measured at amortized cost or at fair value based on the Company’s business model for managing financial assets and the contractual cash flow characteristics of the financial assets. IFRS 9 (2010) requires that financial liabilities are classified as subsequently measured at amortized cost except for financial liabilities classified as fair value through profit or loss, financial guarantees and certain other exceptions. The Company has not yet early adopted this standard and is assessing the impact upon the implementation of this standard.

(b) IFRS 15, Revenue from contracts with customers (“IFRS 15”)

IFRS 15, Revenue from contracts with customers, was issued in May 2014. This standard establishes the principles that an entity shall apply to report useful information to users of financial statements about the nature, amount, timing, and uncertainty of revenue and cash flows arising from a contract with a customer. It specifies how and when a Company will recognise revenue as well as requiring the entity to provide users of financial statements with more informative, relevant disclosures. It further provides a principles based five-step model to be applied to all contracts with customers. This standard is effective for annual periods beginning on or after January 1, 2017. Earlier application is permitted. The Company has not yet assessed the impact of adopting this standard.

FINANCIAL INSTRUMENTS AND OTHER INSTRUMENTS

The Company does not have any financial instruments, other than cash deposited with a reputable banking institution.

RISKS AND UNCERTAINTIES

Political and Regulatory Risk

Failure to comply with applicable laws, regulations, and permitting requirements may result in enforcement actions thereunder. These may include responding to orders issued by regulatory or judicial authorities causing operations to cease or be curtailed, and may include corrective measures requiring capital expenditures, installation of additional equipment, or remedial actions.

Limited Operational History

The Company does not have any significant operations. As a result, there is no assurance that the Company will earn profits in the future or that profitability, if achieved, will be sustained.

Additional Financing

The Company will require additional financing in order to make further developments or take advantage of unanticipated opportunities. The ability of the Company to arrange such financing will depend in part upon prevailing capital market conditions as well as the business performance of the Company. There can be no assurance that the Company will be successful in its efforts to arrange additional financing on terms satisfactory to it. If additional financing is raised by the issuance of shares from treasury, control of the Company may change and shareholders may suffer dilution. If adequate funds are not available or are not available on acceptable terms, the Company may not be able to take advantage of opportunities or otherwise respond to competitive pressures and remain in business.

Key Personnel and Future Staffing Requirements

The Company's success will also be dependent on its ability to identify, recruit, motivate and retain highly qualified executive, management and technical support.

Price Volatility of Public Stock

In recent years, the securities markets in the United States and Canada have experienced a high level of price and volume volatility, and the market price of securities of many companies, particularly those considered to be development stage companies, have experienced wide fluctuations in price which have not necessarily been related to the operating performance or underlying net asset values of such companies.
