The Acquired 3,799,787 common shares (the "Acquired Shares") of the Issuer in connection with the completion of the acquisition by the Issuer of 100% of the issued and outstanding shares of RISE Research Inc. ("RISE") pursuant to an amalgamation agreement dated February 2, 2018 (the "Amalgamation Agreement") involving the Issuer, a newly formed wholly-owned subsidiary of the Issuer and RISE (the "Acquisition"). The Acquiror acquired the Acquired Shares pursuant to the terms of the amalgamation agreement. The amalgamation was completed on February 3, 2018.

Prior to the closing of the Acquisition, the Acquiror, directly and indirectly, owned and controlled 1,900,000 Common Shares representing approximately 5.51% of the issued and outstanding Common Shares of the Issuer.

After giving effect to the Acquisition, the Acquiror, directly and indirectly, owns and control 5,699,787 Common Shares representing approximately 12.95% of the issued and outstanding Common Shares of the Issuer. In addition, the Acquiror owns common share purchase warrants ("**Warrants**") to purchase an aggregate of 1,978,977 common shares of the Issuer. If the Acquiror were to exercise his Warrants, he would own 7,678,764 Common Shares, representing approximately 16.70% of the Issuer's then outstanding Common Shares, on a partially diluted basis.
