On December 1, 2022, the Acquiror acquired ownership of 809,524 Shares at deemed price of \$0.105 per Share through 1267911 BC Ltd., a company owned and operated by the Acquiror, pursuant to the closing of a debt settlement (the “Debt Settlement”) to settle an aggregate of \$85,000 owing in management fees.

Further details relating to the Private Placement may be found in the news release of the Company dated December 1, 2022 and filed on SEDAR.

Prior to the acquisition of Shares under the Debt Settlement, the Acquiror held 1,278,734 Shares and no convertible securities of the Company and the Acquiror’s non-diluted shareholdings represented approximately 12.28% of the Company’s issued and outstanding Shares.

As a result of the acquisition of Shares under the Debt Settlement, the Acquiror now holds 2,088,258 Shares and no convertible securities of the Company and the Acquiror’s non-diluted shareholdings now represent approximately 18.61% of the Company’s issued and outstanding Shares.

The Acquiror acquired ownership of the Shares through 1267911 BC Ltd., a company he owns and operates. See item 2.2.
