

NOTICE OF ANNUAL GENERAL MEETING OF SHAREHOLDERS

NOTICE IS HEREBY GIVEN that an annual general meeting (the "Meeting") of the holders of common shares of Supernova Metals Corp. (the "Company") will be held on **Tuesday, March 28, 2023** at **10:00** am PT for the following purposes:

- 1. To receive the audited financial statements of the Company for the financial year ended December 31, 2021, the auditor's report thereon and the management's discussion and analysis for the financial year ended December 31, 2021;
- 2. To fix the number of directors for the ensuing year at four (4);
- 3. To elect directors of the Company for the ensuing year;
- 4. To appoint Saturna Group, Chartered Professional Accountants LLP, as auditors of the Company for the ensuing year and to authorize the board of directors to fix the auditor's remuneration;
- 5. To approve the omnibus incentive plan of the Company, as more particularly described in the Information Circular; and
- 6. To transact such other business as may properly come before the Meeting or at any adjournment thereof.

Accompanying this notice is the Circular. The Circular contains details of matters to be considered at the Meeting.

Registered Shareholders who attend the Meeting will have an opportunity to participate at the Meeting, regardless of their geographic location.

Due to issues related to the verification of shareholder identity via Zoom, in-person voting will only be permitted if the Company's transfer agent, Endeavor Trust Corporation ("Endeavor Trust") is able to properly verify a shareholder's identity. The Company recommends all shareholders vote their common shares before the proxy cut-off date of 10:00 a.m. (Vancouver Time) on Friday, March 24, 2023 (the "Proxy Deadline").

If you are a registered shareholder and wish to have your vote counted in advance of the Meeting, you will be required to complete, date, sign and return, in the envelope provided for that purpose, the accompanying Proxy for use at the Meeting or any adjournment thereof. The Proxy must be received by our transfer agent, Endeavor Trust, by no later than the Proxy Deadline of 10:00 a.m. PT on Friday, March 24, 2023 or no later than 48 hours (excluding Saturdays, Sundays and holidays) prior to the time to which the Meeting may be adjourned or postponed. Alternatively, you may vote by telephone or via the internet following the instructions provided on the Proxy and in the Circular.

If you are a beneficial holder and have received this Notice of Meeting and accompanying materials through an intermediary, such as an investment dealer, broker, custodian, administrator or other nominee, or a clearing agency in which the intermediary participates, please complete and return the voting instruction form provided to you in accordance with the instructions provided therein
