2.2 State the date of the transaction or other occurrence that triggered the requirement to file this report and briefly describe the transaction or other occurrence.

On October 3, 2023, the Acquiror acquired ownership of 1,742,308 units (each a “**Unit**”) at a price of \$0.065 per Unit pursuant to a private placement (the “**Private Placement**”) for a total purchase price of \$113,250. The Units were acquired by 1267911 BC Ltd., a company owned and operated by the Acquiror.

Each Unit consisted of one common share (each a “**Share**”) and one transferable warrant (each a “**Warrant**”) with each Warrant exercisable to purchase one additional Share of the Company (a “**Warrant Share**”) at an exercise price of \$0.10 per Warrant Share until 4:00 p.m. (Vancouver Time) two (2) years from the closing date of the Private Placement (the “**Expiry Date**”).

Further details relating to the Private Placement may be found in the news release of the Company dated October 3, 2023 and filed on SEDAR+.

Prior to the acquisition of Shares and Warrants pursuant to the Private Placement, the Acquiror held 2,323,258 Shares and the Acquiror’s non-diluted shareholdings represented approximately 20.48% of the Company’s issued and outstanding Shares.

As a result of the acquisition of Units (Shares and Warrants) pursuant to the Private Placement, the Acquiror now holds a total of 4,065,566 Shares and 1,742,308 Warrants and the Acquiror's non-diluted shareholdings now represent approximately 28.19% of the Company's issued and outstanding Shares. Thus, on a partially diluted basis (i.e., assuming full exercise of all Warrants), the Acquiror would hold a total of 5,807,873 Shares, representing approximately 35.93% of the Company's issued and outstanding Shares.
