## **Appointment of Auditors**

99.84% of shares voted were voted in favor of re-appointing MNP LLP as auditor and authorizing the board of directors of the Company to fix the auditors remuneration for the following year.

## Continuation under the *Business Corporations Act* (British Columbia)

99.89% of shares voted were voted in favor of approving the continuance of the Company out of the federal jurisdiction under the *Canada Business Corporations Act* and into the Province of British Columbia under the *Business Corporations Act* (British Columbia) (the "Continuance"), and upon completion of the Continuance, the adoption of the new Articles, as more particularly described in the management information circular for the AGM. The Continuance will not affect the Company's status as a listed reporting issuer on the Canadian Securities Exchange. Planet 13 will provide an update upon completion of the Continuance.
